

RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF JCM INC. AND MILE HIGH GLASS INC. AND AWARDING THE CONTRACT FOR THE CITY HALL EXTERIOR WINDOW RESEALING PROJECT, BID #15-017, IN AN AMOUNT NOT TO EXCEED SIXTY SIX THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$66,750.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal bid process for completion of the City Hall Exterior Window Resealing Project; and

WHEREAS, funding was approved in the 2015 budget for the City Hall Exterior Window Resealing Project; and

WHEREAS, JCM Inc. and Mile High Glass Inc., submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that JCM Inc. and Mile High Glass Inc. is the lowest and most responsive and responsible bidder for the City Hall Exterior Window Resealing Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the bid of JCM Inc. and Mile High Glass Inc. in the amount of Sixty Six Thousand Seven Hundred Fifty Dollars (\$66,750.00), to award the contract for the City Hall Exterior Window Resealing Project to JCM Inc. and Mile High Glass Inc., in an amount not to exceed Sixty Six Thousand Seven Hundred Fifty Dollars (\$66,750.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

1. That JCM Inc. and Mile High Glass Inc. is the lowest responsive and responsible bidder for the City Hall Exterior Window Resealing Project; and
2. That the bid of JCM Inc. and Mile High Glass Inc. in the amount of Sixty Six Thousand Seven Hundred Fifty Dollars (\$66,750.00), is hereby approved; and
3. That funding was approved in the 2015 budget for the City Hall Exterior Window Resealing Project; and

4. That the Contract for the City Hall Exterior Window Resealing Project is hereby awarded to JCM Inc. and Mile High Glass Inc. in the amount not to exceed Sixty Six Thousand Seven Hundred Fifty Dollars (\$66,750.00); and
5. That the Mayor is hereby authorized to sign the contract with JCM Inc. and Mile High Glass Inc. on behalf of the City and the City Clerk to Attest thereto.
