

### History

**2018 - 2019**

- Staff and Council identified concerns that planned projects were not being completed.
- A forensic audit was conducted, overseen by a resident committee.
  - Resulted in recommendations around budgeting practices, which have been implemented.
- Stantec was hired through competitive procurement process to build a rate model.
- Various options were evaluated including leaving rates flat for several years or reducing rates temporarily to spend down reserves.
- November 2019, City Council approved on Final Reading an Ordinance reducing water rates by 8%, effective 2020.

### Proposal #2: Water Treatment Plant Fee

### History

2019 - 2021

- Current Water Treatment Plant is 25 years old and identified as being near end of life, resulting in increased maintenance costs and eventual need for replacement.
- City water usage continued to grow, exceeding the capacity of the current Water Treatment Plant on multiple occasions.
- City Council approved the award of a contract to Brown & Caldwell for the design of an expanded Water Treatment Plant, proposing adding 4 MGD.

2022

- January 25<sup>th</sup> – Staff presented Council with options for Water Treatment Plant expansion. Options had similar costs but different outcomes for capacity. Staff moved forward with the 20 MGD plant design, including updating the rate model.
- April 26<sup>th</sup> – City Council and Staff did a virtual walkthrough of the proposed plant and reviewed cost and rate implications.

### Water Treatment Plant Project Overview

#### Plant Enhancements

- Project timeline
  - Groundbreaking – July 2022
  - Completion – July 2025
- Increase capacity from 10MGD to 20MGD
- Provide water treatment capacity through 2045
- Eliminate costly brine discharge
- Eliminate dependence on Denver/Thornton water
- Utilize the newest water treatment technology

### Water Treatment Plant Project Overview

**Financing**

- Project cost - \$155 million
- Funded through debt issued in two phases (2022 and 2024)
- Debt paid by a combination of Growth and Operational Revenues

**Growth Revenues Development Fees**

- Fees paid by Developers
- Updated effective 2021
- Sufficient to fund the growth portion of the project

**Operational Revenues User Fees**

- Water Treatment Plant Fee
- Flat fee applied to all users
- Starts at \$6/month in January 2023

**Adopt now in order to better position the City to borrow funds for the project.**

### Water Rate Proposal

**July 2022 – Rate Reset 9.11%**


- Reset rates to 2019 levels, adjusted for inflation

**January 2023 – Water Treatment Plant Fee**

- Flat monthly fee based on customer group and historical usage ratios
- Rate starts at \$6/month for Single Family Home (3/4 inch meter)

**Future Adjustments (to be evaluated annually)**

- 2024 – 5%
- 2025 and thereafter – 2.5% - 3.5%

### Customer Impact Analysis

Single Family Home 3/4 inch meter	Current Average Bill	July 2022 9.11%	January 2023 \$6/month	Total Change per month
Winter Usage 4,000 Gallons	\$ 27.19	\$ 29.67	\$ 35.67	\$ 8.48
Summer Usage 14,500 Gallons	\$ 76.86	\$ 83.86	\$ 89.86	\$ 13.00

Average Household Impact – Approximately \$10/month



## Water Assistance Program

**Current Program**

- Available to income qualified customers
- One time assistance of \$300/customer
- Funded at \$50K annually

**Proposed Enhancements**


- Increase support per customer from \$300 to \$500 annually
- Increase total funding from \$50K to \$100K annually
- Program expansion to residents paying via rent or HOA



**Priority**  
Keep essential use affordable

## Water Treatment Plant - Design Contract Amendment

Contractor - Brown & Caldwell, Inc.

The contract is being amended to increase the value by \$3,698,139.


This amendment is due to the change in the scope of work from a 4MGD expansion to a 20MGD new plant design.

Additional support will be required through July 2025. An additional amendment is expected in December 2022.

## Procurement Summary

### Water Treatment Plant Design - Brown & Caldwell, Inc.

A Formal Solicitation was conducted in 2019, resulting in two (2) responses. Each proposer was interviewed as part of the solicitation process, and the evaluation committee choose Brown & Caldwell, Inc. to complete the design for the Water Treatment Plant.

The proposed contract amendment reflects additional work requested by the City for the revised Water Treatment Plant capacity and design.

**Staff Recommendation:**  
Accept the proposed amendment to the Brown & Caldwell, Inc. agreement.

## Water Treatment Plant - Construction Contract

Contactor - Garney Companies, Inc.

The contract being presented today covers the first two phases of construction, totaling \$50,755,402.

Phase I	Phase II
<ul style="list-style-type: none"> <li>Earthwork</li> <li>Purchase long lead items</li> <li>\$24,375,892</li> </ul>	<ul style="list-style-type: none"> <li>Foundation</li> <li>\$26,379,510</li> </ul>

A contract amendment for Phase III is anticipated in December and will include the remainder of the construction amount and scope of work.

## Procurement Summary

### Water Treatment Plant Construction – Garney Companies, Inc.

A Formal Solicitation was conducted the spring of 2020, resulting in four (4) responses. Each proposer was interviewed as part of the solicitation process, and the evaluation committee choose Garney Companies, Inc. for the Construction Manager at Risk for the construction of the Water Treatment Plant.


**Staff Recommendation:**

Accept the proposed agreement with Garney Companies, Inc.

## Bonding Reimbursement Resolution

Project financing includes \$60M Water Revenue Bonds issued in October 2022 and additional financing in 2024.

In order to utilize future bond proceeds on construction costs incurred before the bonds are issued, a resolution is required that states the City's intention to utilize the bonds for construction purposes.

**Staff Recommendation:**

Approve the Bonding Reimbursement Resolution as presented.
