

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF DESIGNSCAPES COLORADO INC. AND AWARDING THE CONTRACT FOR THE NORTH ELEMENTARY - MALCOM PARK PLAY YARD PROJECT, BID #14-043, TO DESIGNSCAPES COLORADO INC. IN AN AMOUNT NOT TO EXCEED TWO HUNDRED NINETY FOUR THOUSAND THREE HUNDRED NINETY DOLLARS (\$294,390.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting bids through its formal bid process for completion of the North Elementary - Malcom Park Play Yard Project; and

**WHEREAS**, funding was approved in the 2014 budget; and

**WHEREAS**, Designscales Colorado Inc., submitted a bid for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Designscales Colorado Inc. is the lowest and most responsive and responsible bidder for the North Elementary - Malcom Park Play Yard Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the bid of Designscales Colorado Inc. in the amount of Two Hundred Ninety Four Thousand Three Hundred Ninety Dollars (\$294,390.00), to award the contract for the North Elementary - Malcom Park Play Yard Project to Designscales Colorado Inc. in an amount not to exceed Two Hundred Ninety Four Thousand Three Hundred Ninety Dollars (\$294,390.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That Designscales Colorado Inc. is the lowest responsive and responsible bidder for the North Elementary - Malcom Park Play Yard Project; and
2. That the bid of Designscales Colorado Inc. in the amount of Two Hundred Ninety Four Thousand Three Hundred Ninety Dollars (\$294,390.00), is hereby approved; and
3. That funding was approved in the 2014 budget in conjunction with the Brighton 27J School District.
4. That the Contract for the North Elementary - Malcom Park Play Yard Project is hereby awarded to Designscales Colorado Inc. in the amount not to exceed Two Hundred Ninety Four Thousand Three Hundred Ninety Dollars (\$294,390.00); and

5. That the Mayor is hereby authorized to sign the contract with Designsapes Colorado Inc. on behalf of the City and the City Clerk to Attest thereto.
