

RESOLUTION NO. 2025-89

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACKNOWLEDGING THE CERTIFIED ABSTRACT OF VOTES CAST FOR THE NOVEMBER 4, 2025, COORDINATED ELECTION

WHEREAS, on July 15, 2025, the City Council of the City of Brighton, Colorado, at a City Council meeting, adopted Resolution 2025-42 approving participation by the City of Brighton in a Coordinated Election to be conducted by the Adams County Clerk and Recorder and the Weld County Clerk and Recorder on November 4, 2025; and

WHEREAS, the Canvass Judges from Adams and Weld Counties have completed their respective Certified Abstract of Votes Cast and have submitted such certified election results to the City Clerk. The combined tally from both Counties for the Coordinated Election is as follows:

WHEREAS, pursuant to C.R.S. Section 1-11-103(2), after the final Abstract of Votes Cast has been prepared and certified, the Designated Election Official shall notify the local governing body of the election results; and

WHEREAS, accordingly, the Adams County and Weld County Canvass Boards reviewed the November 4, 2025, Coordinated Election procedures and election results and certified the Abstract of Votes Cast on November 25, 2025, and November 20, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO:

Section 1. The results of the November 4, 2025, Coordinated Election as follows:

1. That Gregory Mills received the highest number of votes for the City of Brighton Mayor contest and was elected Mayor and shall serve for four (4) years commencing January 6, 2026.
2. That Rhianon Collins received the highest number of votes for the City of Brighton Ward 1 contest and was elected Councilmember from Ward 1 and shall serve for four (4) years commencing January 6, 2026.
3. That Ann Taddeo received the highest number of votes for the City of Brighton Ward 2 contest and was elected Councilmember from Ward 2 and shall serve for four (4) years commencing January 6, 2026.
4. That Melinda Carbajal received the highest number of votes for the City of Brighton Ward 3 contest and was elected Councilmember from Ward 3 and shall serve for four (4) years commencing January 6, 2026.
5. That Peter Padilla received the highest number of votes for the City of Brighton Ward 4 contest and was elected Councilmember from Ward 4 and shall serve for four (4) years commencing January 6, 2026.

Section 2. This Resolution is effective as of the date of its adoption.
