

RESOLUTION NO. 2019-137

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF MUSCO SPORTS LIGHTING, LLC AND AWARDING THE CONTRACT FOR PARK LIGHTING IMPROVEMENTS, PROJECT #19-031, TO MUSCO SPORTS LIGHTING, LLC IN THE AMOUNT OF TWO HUNDRED SEVEN THOUSAND EIGHT HUNDRED DOLLARS (\$207,800.00), AND AUTHORIZING THE ACTING CITY MANAGER TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, the City of Brighton, Colorado (“City”), published a notice inviting bids through its formal bid process for Park Light Improvements, Project #19-031 (“Project”); and

WHEREAS, funding was approved for the Project in the 2019 Budget for Ken Mitchell Park and Colorado Park and in the Approved 2020 Budget for Donelson Park; and

WHEREAS, Musco Sports Lighting, LLC submitted a bid for the Project which has been reviewed by the City; and

WHEREAS, the City believes that Musco Sports Lighting, LLC is the most responsive and responsible bidder for the Project; and

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies;” and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies or services and contracting for public works or professional services.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

Section 1. The bid of Musco Sports Lighting, LLC, in an amount of Two Hundred Seven Thousand Eight Hundred Dollars (\$207,800.00), is hereby accepted.

Section 2. The Acting City Manager is hereby authorized to sign the contract on behalf of the City, and the City Clerk to attest thereto.

Section 3. All resolutions or parts of resolutions of the City in direct conflict herewith are hereby rescinded.
