

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF BERRY DUNN, AND AWARDING THE CONTRACT FOR THE ERP CONSULTING SERVICES PROJECT #17033 IN AN AMOUNT NOT TO EXCEED SEVENTY NINE THOUSAND NINE HUNDRED DOLLARS (\$79,900.00) TO BERRY DUNN, AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting proposals through its formal solicitation process for ERP Consulting Services Projects, (RFP #18-031); and

**WHEREAS**, The ERP Consulting Services project #17033 is within budget; and

**WHEREAS**, Berry Dunn, submitted a proposal for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Berry Dunn, is the most responsive and responsible proposer for the ERP Consulting Services Projects; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the proposal of Berry Dunn, in the amount of Seventy Nine Thousand Nine Hundred Dollars (\$79,900.00), to award the contract for the ERP Consulting Services Projects to Berry Dunn, in an amount not to exceed Seventy Nine Thousand Nine Hundred Dollars (\$79,900.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That Berry Dunn, is the most responsive and responsible proposer for the ERP Consulting Services Projects; and
2. That the proposal of Berry Dunn, in the amount of Seventy Nine Thousand Nine Hundred Dollars (\$79,900.00), is hereby approved; and
3. That the ERP Consulting Services project #17033 is within budget; and
4. That the Contract for the ERP Consulting Services Projects is hereby awarded to Berry Dunn, in the amount not to exceed Seventy Nine Thousand Nine Hundred Dollars (\$79,900.00); and
5. That the Mayor is hereby authorized to sign the contract with Berry Dunn, on behalf of the City and the City Clerk to Attest thereto.
