6. Petition shall be returned to City Clerk's Office to forward to the Parks and Recreation Advisory Board (PRAB) for consideration.
7. Twenty-five (25) signatures must appear on the Petition.
8. If a suggested name is approved by the PRAB, public notice shall be made, with the public invited to next scheduled PRAB Meeting for discussion of name submitted.

Don moved to Colorado in 1948 when he was 26 years old. He settled down in Brighton and bought Brighton Appliance, he owned the store for 40 years until he closed it in 1988. Don was a prominent member of the Brighton business community, having served as a president and treasurer of the Brighton Chamber of Commerce and as president of the Brighton Retail Council. While on the Chamber, Don was an advocate for community parks and getting the outdoor pool in Benedict Park. He was also on the board for Brighton Community Hospital and Platte Valley Medical Center Foundation. He was one of the key leaders to build the original hospital building. He also served as a vice president for the Brighton Lions Club and was a member of the Brighton Elks BPOE #1586.

Don never married, he dedicated all of his time to help make Brighton a better place to live and work.
