

RESOLUTION NO. 2019-105

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE REQUEST OF UTILITIES TO “PIGGYBACK” ON A FORMAL SOLICITATION BY THE CITY AND COUNTY OF BROOMFIELD FOR THE REHABILITATION AND PROTECTIVE LINING OF A PORTION OF THE CITY’S SANITARY SEWER MANHOLES AND APPROVING A CONTRACT WITH CONCRETE CONSERVATION INC. FOR THE TOTAL OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000.00); AND AUTHORIZING THE CITY MANAGER TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, the City and County of Broomfield, Colorado, published an Invitation for Bid #17-016 through its formal bid process for the rehabilitation and protective lining of sanitary sewer manholes and has agreed to allow the City of Brighton, Colorado (“City”), to “piggyback” onto that bid for the same pricing; and

WHEREAS, funding for the repair and replacement of manholes in the amount of Four Hundred Thousand Dollars (\$400,000.00) was approved in the 2019 Sewer Activity Enterprise Fund budget; and

WHEREAS, Concrete Conservation, Inc. submitted a bid for the project, which bid has been reviewed by the City; and

WHEREAS, the City believes that Concrete Conservation, Inc., is the lowest and most responsive and responsible bidder for the rehabilitation and protective lining of sanitary sewer manholes; and

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies”; and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies or services and contracting for public works or professional services; and

WHEREAS, the City believes that it is in the best interests of the City to award the contract for the rehabilitation of approximately two hundred and six (206) of the City’s sewer manholes to Concrete Conservation Inc. in the amount of Four Hundred Thousand Dollars (\$400,000.00) and to authorize the City Manager to sign the contract on behalf of the City; and the City Clerk to attest thereto.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AND ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, AS FOLLOWS:

Section 1. The pricing of Concrete Conservation Inc. under the City and County of Broomfield's Bid # 17-016 in the amount of Four Hundred Thousand Dollars (\$400,000.00) is hereby approved.

Section 2. That the City Manager is authorized to undertake such tasks and execute such documents as may be required to consummate the contract on behalf of the City and the City Clerk to attest thereto.
