

RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE PROPOSAL OF CGRS INC., AND AWARDING THE CONTRACT FOR THE CORE CITY PIPE REPLACEMENT PROJECT TO CGRS INC. IN AN AMOUNT NOT TO EXCEED TWO-MILLION, ONE-HUNDRED EIGHTY-THREE THOUSAND, FIFTY-NINE DOLLARS AND THIRTY-FOUR CENTS (\$2,183,059.34), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, Sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal solicitation process for completion of the Core City Pipe Replacement, (ITB#18-007); and

WHEREAS, funding was approved in the 2017 budget; and

WHEREAS, CGRS Inc. submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that CGRS Inc. is the most responsive and responsible bidder for the Non-Potable Water Master Plan; and

WHEREAS, the City believes that it is in the best interest of the City to accept the bid of CGRS Inc., in the amount of Two-million, one-hundred eighty-three thousand, fifty-nine dollars and thirty-four cents (\$2,183,059.34), to award the contract for the Core City Pipe Replacement to CGRS Inc., in an amount not to exceed of Two Million, One Hundred Eighty-Three Thousand, Fifty-Nine Dollars And Thirty-Four Cents (\$2,183,059.34), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ENTERPRISE, AS FOLLOWS:

1. That CGRS Inc. is the most responsive and responsible bidder for the Core City Pipe Replacement; and

2. That the bid of CGRS Inc. in the amount of Two Million, One Hundred Eighty-Three Thousand, Fifty-Nine Dollars And Thirty-Four Cents (\$2,183,059.34), is hereby approved; and
3. That funding was approved in the 2018 Budget; and
4. That the Contract for the Core City Pipe Replacement is hereby awarded to CGRS Inc. in the amount of Two Million, One Hundred Eighty-Three Thousand, Fifty-Nine Dollars And Thirty-Four Cents (\$2,183,059.34); and
5. That the Mayor is hereby authorized to sign the contract with CGRS Inc., on behalf of the City, and the City Clerk to Attest thereto.
