

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF MIRACLE RECREATION EQUIPMENT, CO., INC., AND AWARDING THE CONTRACT FOR THE BRIGHTON PARK 2 DESTINATION PLAYGROUNDS PROJECT, PROJECT # 97500, IN AN AMOUNT NOT TO EXCEED SIX HUNDRED SEVENTY FOUR THOUSAND ONE HUNDRED FIFTY FIVE DOLLARS (\$674,155.00) TO MIRACLE RECREATION EQUIPMENT, CO., INC., AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting proposals through its formal solicitation process for Brighton Park 2 Destination Playgrounds Project, (RFP #17-060); and

**WHEREAS**, funding was approved in the 2018 budget; and

**WHEREAS**, Miracle Recreation Equipment, Co., Inc., submitted a proposal for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Miracle Recreation Equipment, Co., Inc., is the most responsive and responsible bidder for the Brighton Park 2 Destination Playgrounds Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the proposal of Miracle Recreation Equipment, Co., Inc., in the amount of Six Hundred Seventy Four Thousand One Hundred Fifty Five Dollars (\$674,155.00), to award the contract for the Brighton Park 2 Destination Playgrounds Project to Miracle Recreation Equipment, Co., Inc., in an amount not to exceed Six Hundred Seventy Four Thousand One Hundred Fifty Five Dollars (\$674,155.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That Miracle Recreation Equipment, Co., Inc., is the most responsive and responsible bidder for the Brighton Park 2 Destination Playgrounds Project; and
2. That the proposal of Miracle Recreation Equipment, Co., Inc., in the amount of Six Hundred Seventy Four Thousand One Hundred Fifty Five Dollars (\$674,155.00), is hereby approved; and
3. That funding was approved in the 2018 budget; and

4. That the Contract for the Brighton Park 2 Destination Playgrounds Project is hereby awarded to Miracle Recreation Equipment, Co., Inc., in the amount not to exceed Six Hundred Seventy Four Thousand One Hundred Fifty Five Dollars (\$674,155.00); and
5. That the Mayor is hereby authorized to sign the contract with Miracle Recreation Equipment, Co., Inc., on behalf of the City and the City Clerk to Attest thereto.
