5. Must sign own given name (first name or first initial and last name). **No individual may sign for another individual.**
6. Petition shall be returned to City Clerk's Office to forward to the Special Citizens Committee for consideration.
7. Twenty-five (25) signatures must appear on the Petition.
8. If a suggested name is approved by the Special Citizens Committee, it shall then be forwarded to the City Council and made into a resolution to be approved or denied.
