I am writing this letter to inform you of upcoming public hearings, which you may be inclined to attend. The hearings provide an opportunity for interested parties to voice their opinion on the proposed designation to the Historic Preservation Commission and City Council. The input and opinions of residents and neighboring property owners provides valuable feedback to the Historic Preservation Commission, City Council, City staff, and the applicant. The following is some basic information that pertains to the project.

**Application Type:** Historic Landmark Designation: A request to locally designate a structure as a

historic landmark.

**Summary:** The request is for approval of a historic landmark designation for a Property

located at 319 South Main Street. The Property, approximately .14 acres in size, is eligible for designation under both the Architectural and Social and Historic categories per the Land Use & Development Code. Formally designating the site as a historic landmark will indefinitely preserve the character-defining

features of the structure.

**Location/Site Plan:** The Property is generally located to the south of Skeel Street, to the west and

north of South Main Street, and to the east of Highway 85 and the Pavilions

Development.

The abbreviated legal description is as follows: The northwest quarter of Section 7, Township 1 South, Range 66 West of the 6th Principal Meridian, City of Brighton, County of Adams, State of Colorado. **See the reverse side for a** 

vicinity map.

**Reviewing Bodies:** The Historic Preservation Commission makes a recommendation, and the City

Council decides on the proposed designation after a public hearing (details

below).
