Amendment Purpose

- The City can only spend money that has been appropriated by the Council
- Amendment Need:
 - Awarded grant allocations
 - Increase to 2025 small business
 grant funds
 - Increase in water rates paid by the Water Enterprise Fund
- Sufficient appropriations do not exist to cover these items
