Background Cont.

Pedestrian obstructions on roadway medians, at traffic intersections, and in the public roadway is unsafe and hazardous for motorists, pedestrians, and the general public.

Background Cont.

Obstructions on roadway median strips, at traffic intersections, and in the public roadway increases the risk of motorists becoming distracted from their primary duty to watch traffic, which may result in automobile accidents, pedestrian accidents, congestion and blockage of streets, and delay and obstruction of the free flow of travel, all of which constitute substantial traffic safety problems.
