4. Brief summary for name consideration for a Memorial Parkway Recognition Plaque.
5. Must sign own given name (first name or first initial and last name). No individual may sign for another individual.
6. Petition shall be returned to City Clerk's Office to forward to the Parks and Recreation Advisory Board (PRAB) for consideration.
7. Twenty-five (25) signatures from Brighton residents, must appear on the Petition.
8. If a suggested name is approved by the PRAB, public notice shall be made, with the public invited to next scheduled BRAB Meeting for Discussion of name submitted.
