

RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE PROPOSAL OF MARTIN/MARTIN AND AWARDING THE CONTRACT FOR THE RO CONCENTRATE RESOLUTION PROJECT TO MARTIN/MARTIN CONSULTING ENGINEERS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SEVENTY-FOUR THOUSAND ONE HUNDRED EIGHTY-FIVE DOLLARS (\$174,185.00) AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, Sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting qualifications through its formal solicitation process, resulting in the short-listing of four pre-qualified engineering consultants; and

WHEREAS, the City subsequently published a notice inviting bids through its formal solicitation process for the pre-qualified engineering consultants for completion of the RO Concentrate Resolution Project, (RFP# 18-030); and

WHEREAS, funding was approved in the 2018 budget; and

WHEREAS, Martin/Martin Engineering Consultants submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that Martin/Martin Engineering Consultants is the most responsive and responsible bidder for the RO Concentrate Resolution Project; and

WHEREAS, the City believes that it is in the best interest of the City to accept the bid of Martin/Martin Engineering Consultants, in the amount of One Hundred Seventy-four Thousand One Hundred Eighty-five Dollars (\$174,185.00), to award the contract for the RO Concentrate Resolution Project to Martin/Martin Engineering Consultants in an amount not to exceed One Hundred Seventy-four Thousand One Hundred Eighty-five Dollars (\$174,185.00), and to authorize the Mayor to sign the contract on behalf of the City, and the City Clerk to Attest thereto.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, AS FOLLOWS:

1. That Martin/Martin Engineering Consultants, is the most responsive and responsible bidder for the RO Concentrate Resolution Project; and
2. That the bid of Martin/Martin Engineering Consultants, in the amount of One Hundred Seventy-four Thousand One Hundred Eighty-five Dollars (\$174,185.00), is hereby approved; and
3. That funding was approved in the 2018 Budget; and
4. That the Contract for the RO Concentrate Resolution Project is hereby awarded to Martin/Martin Engineering Consultants in the amount of One Hundred Seventy-four Thousand One Hundred Eighty-five Dollars (\$174,185.00); and
5. That the Mayor is hereby authorized to sign the contract with Martin/Martin Engineering Consultants, on behalf of the City, and the City Clerk to Attest thereto.
