

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO APPROVING THE LEASE OF A 92.5 ACRE PARCEL OF CITY-OWNED LAND, THE "COLE PROPERTY", TO DAVID AND RHONDA LOEFFLER; SETTING OUT THE TERMS OF SAID LEASE; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID LEASE ON BEHALF OF THE CITY**

**ORDINANCE NO. 2189**

**INTRODUCED BY: Baca**

**WHEREAS**, pursuant to Section 17.3 of the City of Brighton Charter, the City Council may not " ... *mortgage or encumber public utilities or permanent public buildings or real or personal property except by ordinance or majority vote of the electors at the option of the Council*"; and

**WHEREAS**, the City owns a 92.5 acre parcel of land, The "Cole Property" which has been acquired for public purposes, and upon which the City deems it to be appropriate to permit farming operations, consistent with certain terms and conditions; and

**WHEREAS**, to that end, the City has negotiated and presents to the Council for approval, a Farm Lease with Dave and Rhonda Loeffler on the "Cole Property"; and

**WHEREAS**, the City Council finds and determines that the terms of said Farm Lease are reasonable, and that it is in the best interests of the City to enter into said Farm Lease with Dave and Rhonda Loeffler.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:**

**Section 1.** The Farm Lease by and between the City of Brighton and Dave and Rhonda Loeffler, for the approximate Ninety two and 5/10 (92.5) acre parcel of City-owned land located generally in Section 5, Township 1 North, Range 66 West of the 6<sup>th</sup> P.M., County of Adams, State of Colorado (referred to as the "Cole Property") is hereby approved.

**Section 2.** The City Manager is hereby authorized to execute such documents and undertake such actions as may be necessary to finalize and enforce said Farm Lease, and any extensions thereof, on behalf of the City.
