

RESOLUTION NO. 2015-86

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO APPROVING THE UPDATED 2016-2018 INTERGOVERNMENTAL AGREEMENT BETWEEN ADAMS COUNTY AND THE CITY OF BRIGHTON FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM; AND AUTHORIZING THE MAYOR TO EXECUTE THE UPDATED "IGA" ON BEHALF OF THE CITY.

WHEREAS, the City of Brighton and Adams County entered into an Intergovernmental Agreement ("IGA") regarding the 2013-2015 Community Development Block Grant Entitlement Program ("CDBG Entitlement Program"), in August, 2013; and

WHEREAS, at its regular meeting on June 23, 2015, the City Council adopted Resolution #2015-69, whereby the City of Brighton and Adams County approved an updated IGA to address the CDBG Program for 2016-2018; and

WHEREAS, subsequent thereto, Brighton, as well as other cities in Adams County, received a further revised IGA from the Community Planning & Development Department of the U.S. Department of Housing & Urban Development and Adams County, which revision, generally, clarifies the three year term covered by the IGA, the automatic renewal provision requirements, and certain understandings related to participation in the program; and

WHEREAS, the initial term of the IGA covers the CDBG Entitlement Program for a three year period, beginning on March 1, 2016, and ending on February 28, 2019;

WHEREAS, as proposed, the IGA will automatically be renewed for an additional three (3) year term unless either party provides written notice that it elects not to participate in a new qualification period; the County will provide notice to the City of Brighton of its right not to participate in the additional term, pursuant to applicable HUD regulations; and

WHEREAS, the IGA is funded through the Department of Housing and Urban Development ("HUD") which receives funding annually from Congress, who appropriates funding annually. Such appropriations decide how much funding is available for CDBG.

WHEREAS, this IGA will remain in effect until the CDBG funds and program income received with respect to activities carried out during the three-year qualification period and any applicable successive qualification periods are expended and the funded activities completed; the County and the City of Brighton cannot terminate or withdraw from the IGA while it remains in effect; and


WHEREAS, the City Council finds and determines that participation in the CDGB Entitlement Program is a benefit to the citizens of Brighton that the terms of the updated IGA are reasonable, and it is in the best interests of the City to enter into the updated IGA with Adams County.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF BRIGHTON THAT:**




