

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF JR ENGINEERING, AND AWARDING THE CONTRACT FOR THE NORTH 40TH AVENUE IMPROVEMENTS – BRIDGE STREET TO GARCIA AVENUE PROJECT, PROJECT # 99825 IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY SEVEN THOUSAND NINE HUNDRED NINETY FOUR DOLLARS (\$157,994.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, *“The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies”*; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting proposals through its formal solicitation process for completion of the North 40th Avenue Improvements – Bridge Street to Garcia Avenue Project, (RFP #17-015); and

**WHEREAS**, funding was approved in the 2017 Budget; and

**WHEREAS**, JR Engineering, submitted a proposal for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that JR Engineering, is the firm having the requisite expertise and experience to perform the required services for the North 40th Avenue Improvements – Bridge Street to Garcia Avenue Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the proposal of JR Engineering, in the amount of One Hundred Fifty Seven Thousand Nine Hundred Ninety Four Dollars (\$157,994.00), to award the contract for the North 40th Avenue Improvements – Bridge Street to Garcia Avenue Project to JR Engineering, in an amount not to exceed One Hundred Fifty Seven Thousand Nine Hundred Ninety Four Dollars (\$157,994.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That JR Engineering is the firm having the requisite expertise and experience to perform the required services for the North 40th Avenue Improvements – Bridge Street to Garcia Avenue Project; and
2. That the Proposal of JR Engineering in the amount of One Hundred Fifty Seven Thousand Nine Hundred Ninety Four Dollars (\$157,994.00), is hereby approved; and
3. That funding was approved in the 2017 Budget; and

4. That the Contract for the North 40th Avenue Improvements – Bridge Street to Garcia Avenue Project is hereby awarded to JR Engineering in the amount not to exceed One Hundred Fifty Seven Thousand Nine Hundred Ninety Four Dollars (\$157,994.00); and
5. That the Mayor is hereby authorized to sign the contract with JR Engineering, on behalf of the City and the City Clerk to Attest thereto.
