

RESOLUTION NO. 2024-65

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPOINTING MEMBERS TO THE CITY OF BRIGHTON YOUTH COMMISSION FOR TERMS ENDING IN JUNE OF 2026

WHEREAS, the City Council of the City of Brighton, Colorado ("City Council"), on April 14, 2006, adopted Ordinance No. 1881, which repealed Article 2-24 and enacted Article 2-25 of the Brighton Municipal Code, entitled City of Brighton Youth Commission; and;

WHEREAS, Article 2-25 of the Brighton Municipal Code sets out the duties, membership requirements, terms of office, and organizational procedures for the Youth Commission; and

WHEREAS, the City Council desires to empower, support, and inform youth and formed a Youth Commission that advises City Council on youth issues, plans and organizes community events, and generally improves the lives of youth and families in the City; and

WHEREAS, the City Council embraces the inclusiveness of the selection process as facilitated by the interview team and has delegated the interviewing process to the Youth Commission; and

WHEREAS, the City Council concurs with the selection process and supports the recommendation of the Youth Commission and the Mayor and appoints the following candidates to the Youth Commission.
