A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF SABELL'S ENTERPRISE LLLP AND AWARDING THE CONTRACT FOR THE HIGHWAY 7 AND MILLER STREET XERIC LANDSCAPE IMPROVEMENTS, BID #15-019, IN AN AMOUNT NOT TO EXCEED EIGHTY NINE THOUSAND SIX HUNDRED 25/100 DOLLARS (\$89,600.25), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal bid process for completion of the Highway 7 and Miller Street Xeric Landscape Improvements; and

WHEREAS, funding was approved in the 2015 budget for the Highway 7 and Miller Street Xeric Landscape Improvements; and

WHEREAS, SaBell's Enterprise LLLP, submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that SaBell's Enterprise LLLP is the lowest and most responsive and responsible bidder for the Highway 7 and Miller Street Xeric Landscape Improvements; and

WHEREAS, the City believes that it is in the best interests of the City to accept the bid of SaBell's Enterprise LLLP in the amount of Eighty Nine Thousand Six Hundred 25/100 Dollars (\$89,600.25), to award the contract for the Highway 7 and Miller Street Xeric Landscape Improvements to SaBell's Enterprise LLLP, in an amount not to exceed Eighty Nine Thousand Six Hundred 25/100 Dollars (\$89,600.25), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

1. That SaBell's Enterprise LLLP is the lowest responsive and responsible bidder for the Highway 7 and Miller Street Xeric Landscape Improvements; and
2. That the bid of SaBell's Enterprise LLLP in the amount of Eighty Nine Thousand Six Hundred 25/100 Dollars (\$89,600.25), is hereby approved; and

3. That funding was approved in the 2015 budget for the Highway 7 and Miller Street Xeric Landscape Improvements; and
4. That the Contract for the Highway 7 and Miller Street Xeric Landscape Improvements is hereby awarded to SaBell's Enterprise LLLP in the amount not to exceed Eighty Nine Thousand Six Hundred 25/100 Dollars (\$89,600.25); and
5. That the Mayor is hereby authorized to sign the contract with SaBell's Enterprise LLLP on behalf of the City and the City Clerk to Attest thereto.
