Strategic Growth and Infrastructure

- Water Treatment Plant construction
- Lutz Reservoir project
- 10–15-year models for each fund that factor in expected new programs in future years
- Capital plan includes water resource acquisitions funding for when opportunities arise
- Sewer fund plans for needs of future city development
- Continues Affordable Housing Coordinator position





Destination for Recreation and Cultural Amenities

- Rec Plex construction
 - Including a \$3M grant
- Recreation Center Expansion
- Lodging tax grants available for city events, arts, and culture programs, as well as for external entities supporting arts and culture
- Continues funding of current programs for arts & culture, special events, and recreation
- Needs assessment for Sue Corbett Adult Center at Eagle View





Economic Acceleration

- Additional funding for Economic Development Corporation's Small Business Improvement Grant
- BURA administrative assistant increased to a fulltime employee
- Funds staff to continue work on the Brighton Urban Renewal Authority and economic development programming

- Increased staff and operations for new processes at new Water Treatment Plant
- Allows for continued support of the Utilities Department strategic plan
- Continues current software as well as supports staff reviewing use of software for needs





Organizational Excellence

- Continued focus on continuous process improvement and efficiencies
- Actualized overtime savings from Target 36
- Continuation of Performance and Leadership Academy programming
- Working with Enterprise on vehicle replacements allows more opportunity for hybrid and EVs
- Continuation of Management Fellow and Law Clerk position to provide growth opportunities, as well as assistance with workload for Departments





Transportation Adaptability

- Sable Corridor Improvements updated to include funding of storm improvements
- Sable/E-470 Payments
- Continuation of the RTD Microtransit Grant
- Continuation of Sidewalk Connectivity
- Inflation added across the five-year plan for the Annual Transportation Preservation and Improvements Project
- Additional temporary personnel dollars for streets maintenance team
