A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE URBAN DRAINAGE AND FLOOD CONTROL DISTRICT FOR NORTH OUTFALL PHASE III IMPROVEMENTS AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT

WHEREAS, pursuant to § 29-1-203 et seq. of the Colorado Revised Statutes, governmental entities are authorized and encouraged to cooperate or contract with one another to provide any function, service, or facility and to share in the costs of services or functions for their mutual benefit; and

WHEREAS, the Urban Drainage and Flood Control District, doing business as the Mile High Flood District (the "District"), was formed to adopt floodplain regulations, develop master plans and engage in floodplain management; and

WHEREAS, the District has agreed to assist the City of Brighton ("City") with the design and construction of drainage and flood control improvements for the North Outfall Phase III – Eagle Ridge Academy to Bridge Street (the "Improvements"), which are necessary to provide efficient stormwater drainage in that area; and

WHEREAS, the District and the City find that drainage system maintenance and construction is necessary for the health, safety, and welfare of the residents of the City and surrounding area; and

WHEREAS, the City Council finds this agreement to cooperate and share in the costs with the District of the Improvements will benefit residents of the City by preventing damage and loss due to flooding, and the funds to be contributed by the City have been appropriated in the 2025 budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Brighton, Colorado, as follows:

<u>Section 1</u>. The Agreement Regarding Design and Construction of Drainage and Flood Control Improvements for North Outfall Phase III Eagle Ridge Academy to Bridge Street (the "Agreement") Avenue is hereby approved.

Section 2. The City Manager is hereby authorized to execute the Agreement on behalf of the City in substantially the form presented at this meeting, with such technical additions, deletions, or variations as the City Attorney may deem necessary or appropriate and not inconsistent with this Resolution, and to undertake such actions as may be necessary to finalize said Agreement, and any amendments thereof, on behalf of the City.
