

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF BREKHUS MARBLE & GRANITE, LLC., AND AWARDING THE CONTRACT FOR THE BRIGHTON VIETNAM VETERANS MEMORIAL STONE PILLAR MONUMENTS PROJECT #17018, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED ELEVEN THOUSAND SEVEN HUNDRED SIX DOLLARS AND SIXTY CENTS (\$111,706.60); AUTHORIZING A 2018 BUDGET AMENDMENT IN THE AMOUNT OF TWENTY TWO THOUSAND DOLLARS (\$22,000); AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting proposals through its formal solicitation process for completion of the Brighton Vietnam Veterans Memorial Stone Pillar Monuments Project, (RFP #18-010); and

WHEREAS, Brekhush Marble & Granite, LLC, submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that Brekhush Marble & Granite, LLC, is the most responsive and responsible proposer for the Brighton Vietnam Veterans Memorial Stone Pillar Monuments Project; and

WHEREAS, a 2018 budget amendment, transferring funds from the Capital Improvement Fund (fund balance), to Project #17018: Veteran’s Memorial, in the amount of \$22,000 is necessary to complete the Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the proposal of Brekhush Marble & Granite, LLC, in the amount of One Hundred Eleven Thousand Seven Hundred Six Dollars and Sixty Cents (\$111,706.60), to award the contract for the Brighton Vietnam Veterans Memorial Stone Pillar Monuments Project to Brekhush Marble & Granite, LLC., in an amount not to exceed One Hundred and Eleven Thousand Seven Hundred Six Dollars and Sixty Cents (\$111,706.60), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

1. That Brekhush Marble & Granite, LLC, is the most responsive and responsible proposer for the Brighton Vietnam Veterans Memorial Stone Pillar Monuments Project; and
2. That the proposal of Brekhush Marble & Granite, LLC, in the amount of One Hundred Eleven Thousand Seven Hundred Six Dollars and Sixty Cents (\$111,706.60), is hereby approved; and

3. That the 2018 Budget is hereby amended and appropriated for the fiscal year beginning January 1, 1018 and ending December 31, 2018 as follows:

4. That the Contract for the Brighton Vietnam Veterans Memorial Stone Pillar Monuments Project is hereby awarded to Brekhus Marble & Granite, LLC, in the amount not to exceed One Hundred Eleven Thousand Seven Hundred Six Dollars and Sixty Cents (\$111,706.60); and
5. That the Mayor is hereby authorized to sign the contract with Brekhus Marble & Granite, LLC, on behalf of the City and the City Clerk to Attest thereto.
