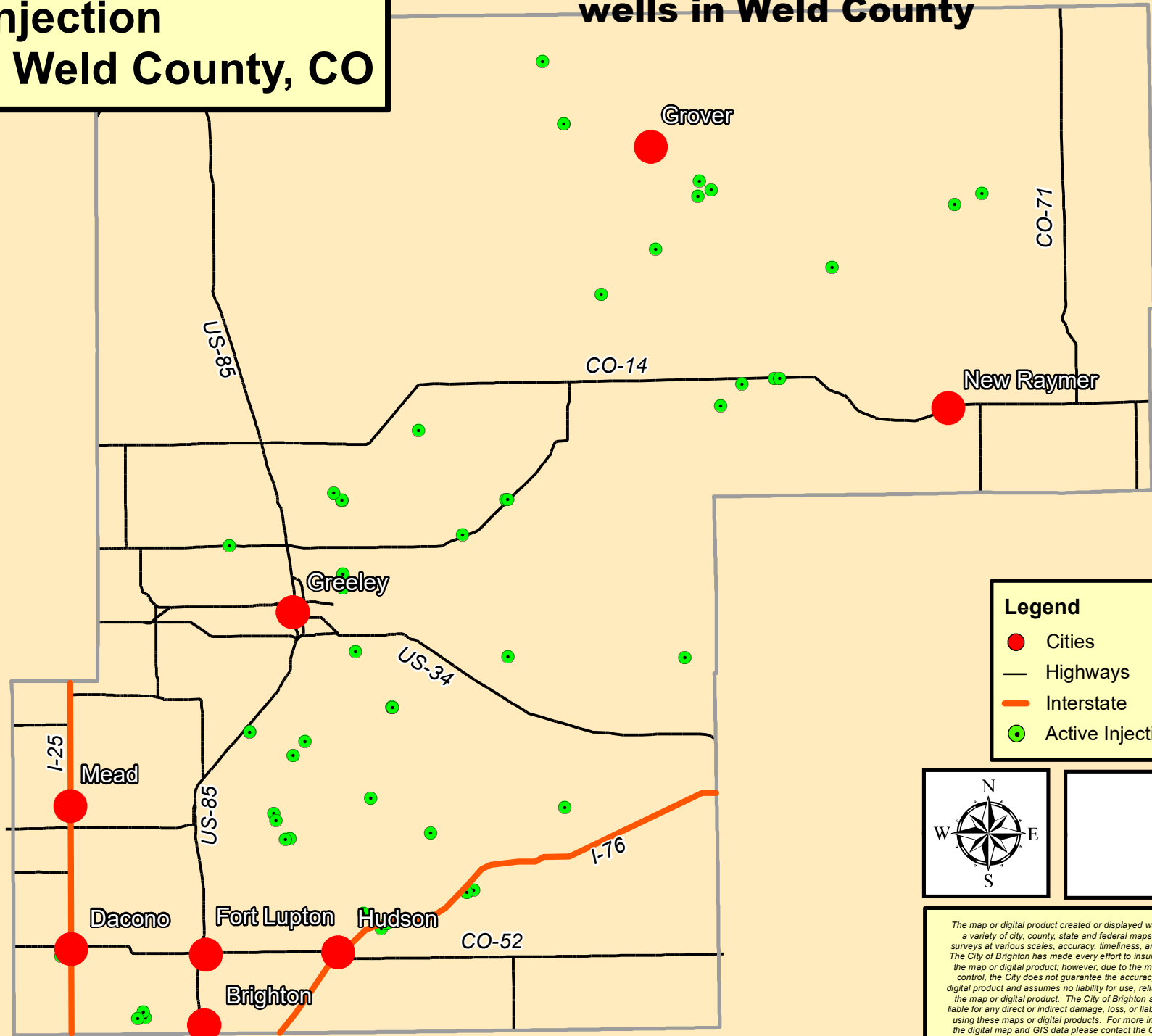


Active Injection Wells in Weld County, CO
