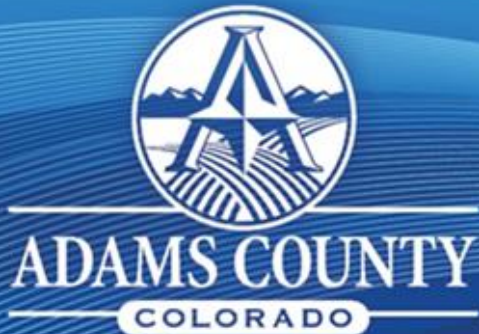

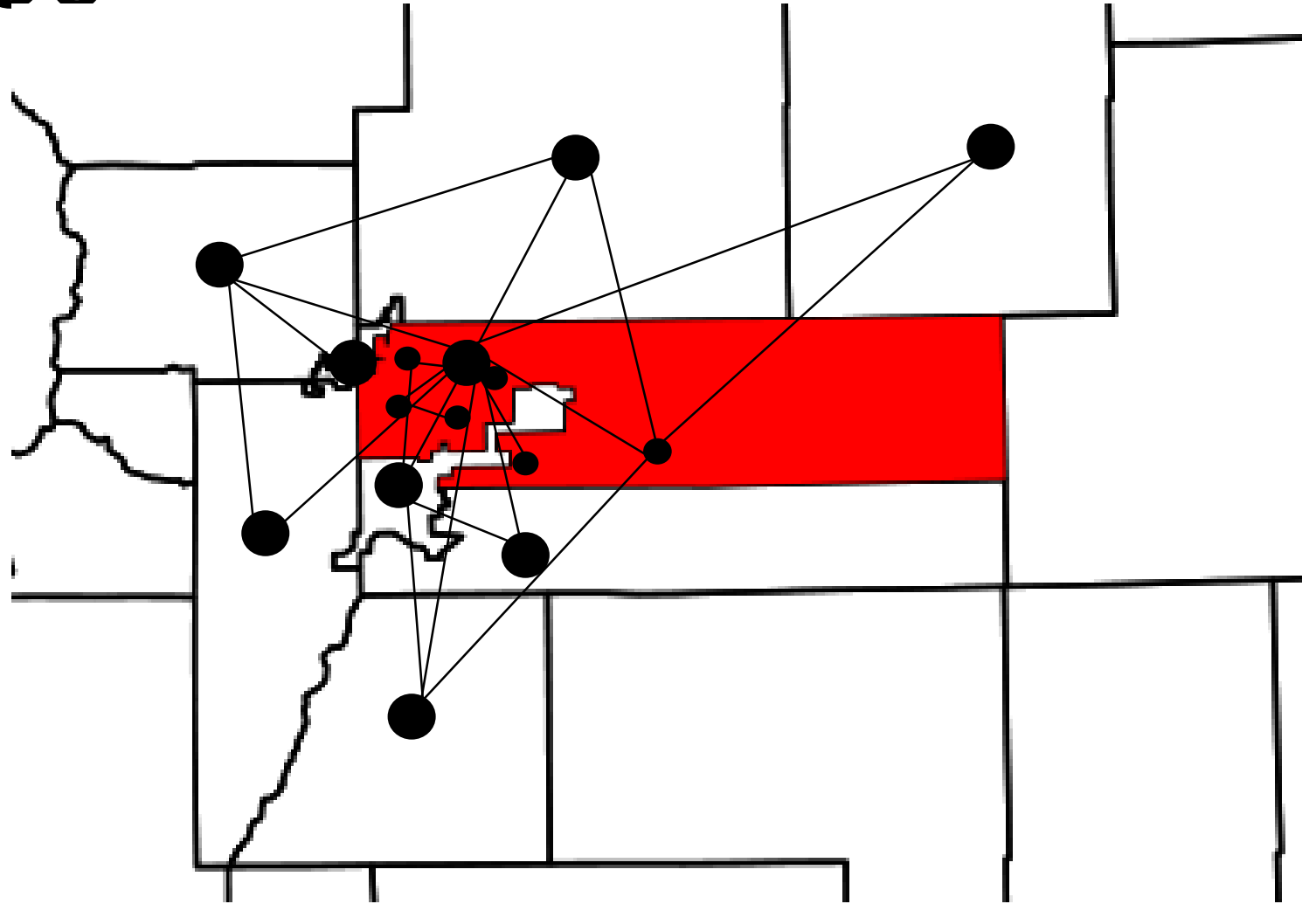
# OVERVIEW

- Began in August to align on homelessness and housing
- Leadership and staff from Adams County, its municipalities, and Broomfield
- Memorandum of Understanding (MOU) on Homelessness



# PURPOSE OF MOU

- Shared vision
- Strengthen regional coordination
- Improve outcomes for people experiencing homelessness
- Evidence-based approach



# KEY COMPONENTS OF MOU

- Three-year term that can renew annually
- Share data and create a central hub to analyze root causes and best solutions to homelessness
- Use data to identify opportunities
- Work with Core Team to deliver outputs and outcomes



# COLLABORATION OUTCOME: TRANSPORTATION ACCESS



## **Outputs:**

- 911 rides
- 460 unique riders
- 7,974 miles driven
- \$21 per ride
- 151 trained dispatchers

## **Eligible Riders:**

- People experiencing homelessness
- People facing an eviction
- People fleeing domestic violence

## **Ride Purposes:**

- Shelter
- Food pantries
- Medical appointments
- Housing appointments
- Communication

## Resource Guide for people Facing an Eviction

You're probably reading this because you've received an eviction notice. This is a stressful time and this resource guide was designed to guide you through the next steps.

### FOLLOW THESE STEPS:

- ☐ TAKE A DEEP BREATH.
- ☐ APPLY FOR RENTAL ASSISTANCE AND TENANT - LANDLORD MEDIATION.
- ☐ APPLY FOR LEGAL ASSISTANCE.
- ☐ FILE AN ANSWER WITH LEGAL SUPPORT.
- ☐ IF NEEDED, PLAN TO ATTEND YOUR COURT DATE WHICH MAY INCLUDE ASKING FOR WORK OFF, PRINTING EVIDENCE/ DOCUMENTATION, AND ARRANGING TRANSPORTATION.
- ☐ PLAN FOR THE WORST BUT HOPE FOR THE BEST!

### WHAT IS AN EVICTION?

Forceable Entry and Unlawful Detainer (F.E.D.), commonly known as an eviction, is legally removing someone from a property, such as a house or an apartment.

### WHAT IS AN ANSWER?

Once you've received an eviction notice, you must file an answer. This is a formal method of admitting, denying, or questioning the eviction. An answer must be filed at the Adams County Justice Center.

**Tip:** You will likely not win a case based on the inability to pay rent. Your landlord must follow certain steps and procedures to legally remove you from a property. Reach out to legal aid organizations for advice on how to file your answer.

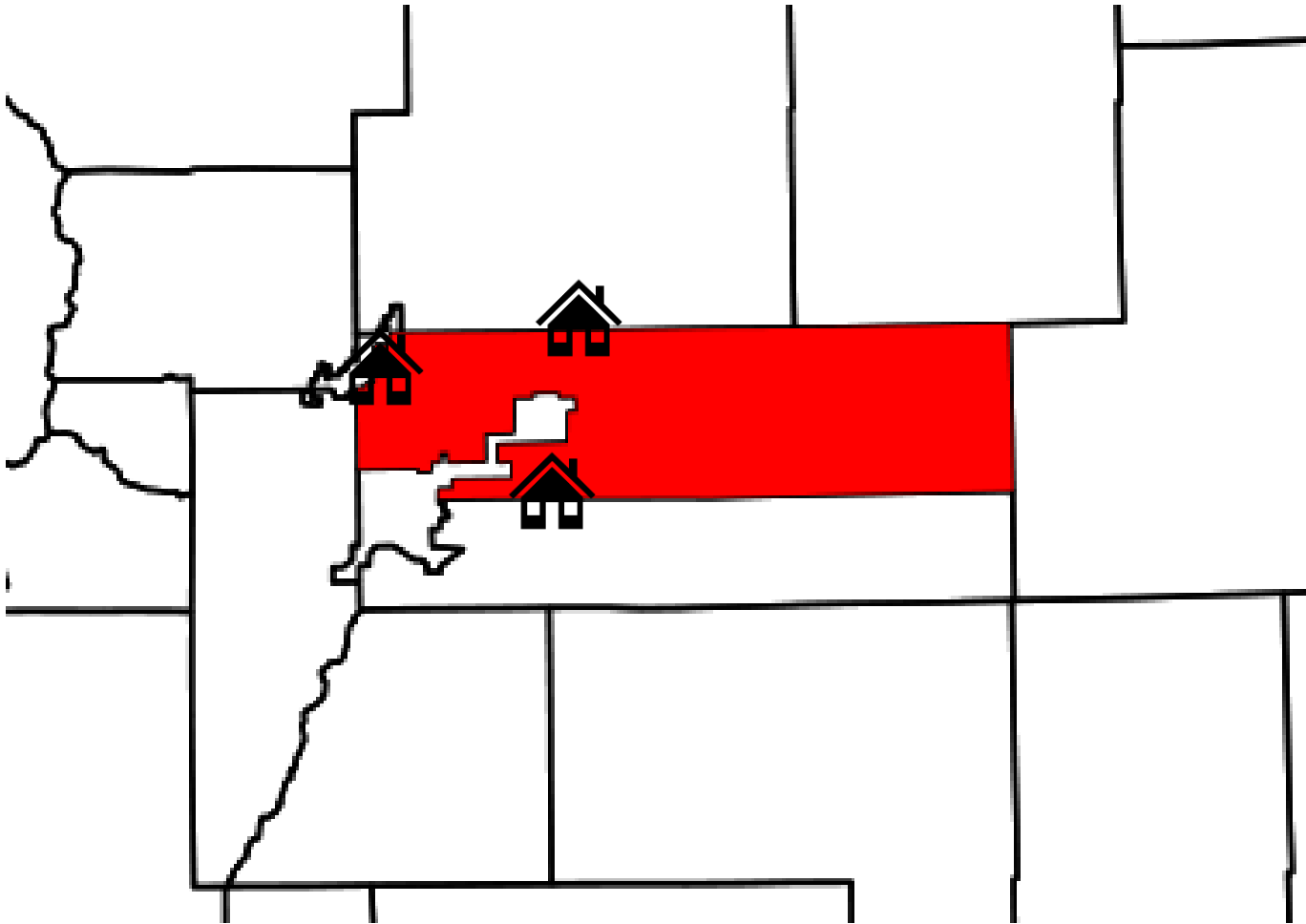


# COLLABORATION OUTCOME: BUILT FOR ZERO

- **Total cases: 83**
  - Housed: 27
  - Literally homeless: 18
  - Could not be contacted for 90+ days: 14
  - Moved to list in another community: 9
  - Determined not to be a veteran: 8
  - Vouchered but not yet leased: 5
  - Incarcerated: 1
  - Deceased: 1



# COLLABORATION INNOVATIONS: THINKING REGIONALLY

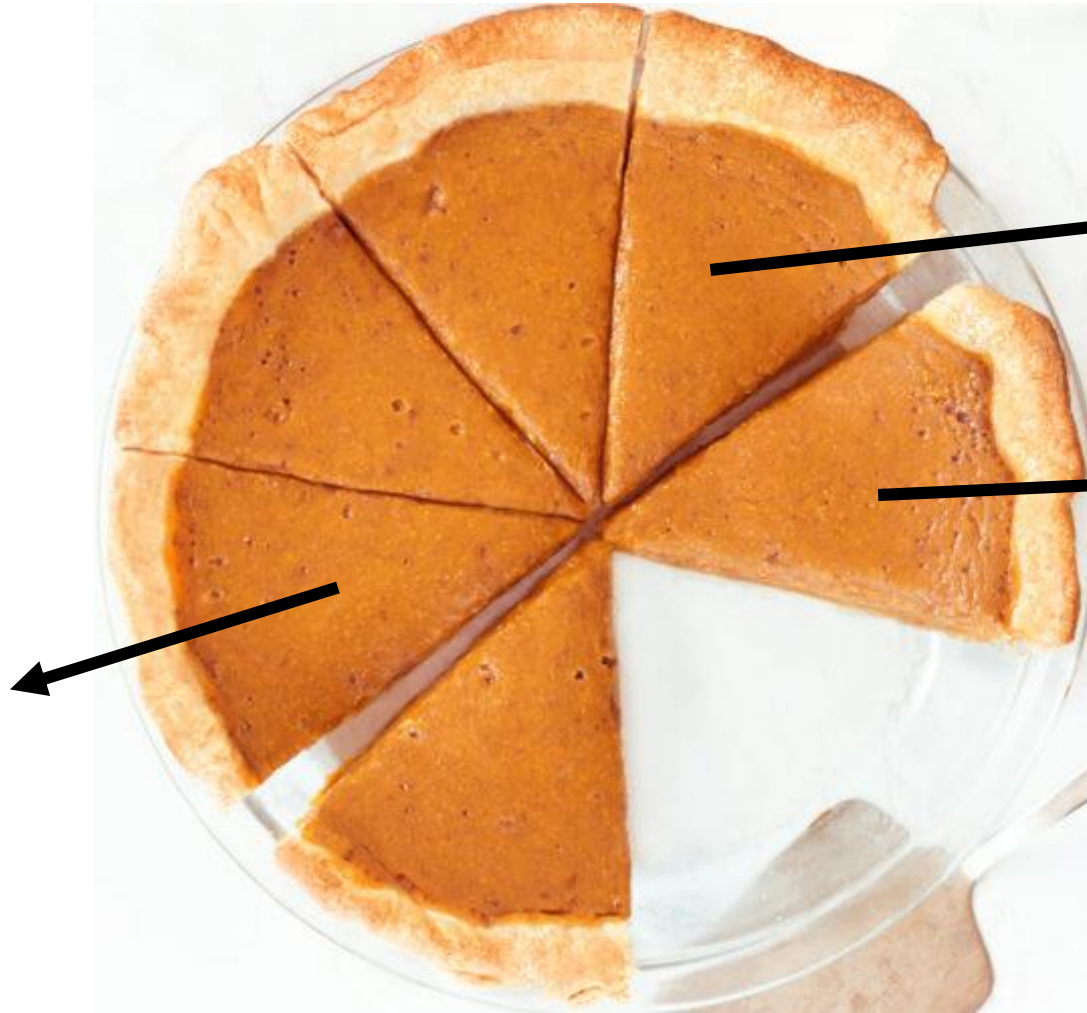


Municipality 1: Money
