RESOLUTION NO. <u>2020-128</u>

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPROVING THE PLACEMENT OF A PLAQUE ON MEMORIAL PARKWAY RECOGNIZING THURSTON WILLIAM "BILL" WALLACE FOR HIS SERVICE TO THE BRIGHTON COMMUNITY

WHEREAS, heretofore, the City Council of the City of Brighton adopted Resolution No. 03-14, establishing a Policy for the naming of public amenities and park and recreation facilities in the City of Brighton, including the procedure for selecting Names for recognition on the Memorial Parkway (the "Naming Policy"); and

WHEREAS, the City Clerk has received one Petition, submitted pursuant to and in accordance with the Naming Policy, requesting recognition of Thurston William "Bill" Wallace for his service to the Brighton Community; and

WHEREAS, Thurston William "Bill" Wallace exemplified the true spirt of volunteerism and public service in Brighton. He was a local attorney who volunteered his time doing pro bono work representing the indigent and underserved. He was active in Toastmasters, the Colorado and Adams County Bar Associations, and at the First Presbyterian Church where he sang in the choir and served as an Elder; and

WHEREAS, the Parks and Recreation Advisory Board has reviewed the Petition, and has found and determined that the Petition properly meets all of the relevant criteria established by the Naming Policy; and

WHEREAS, The Park and Recreation Advisory Board at their meeting on November 4, 2020 recommended that Thurston William "Bill" Wallace be recognized for his service to the Brighton Community by placing a plaque on the Memorial Parkway; and

WHEREAS, The City Council finds and determines that The Parks and Recreation Advisory Board, at their meeting of November 4, 2020, did unanimously approve the motion recommending to the City Council, the Advisory's Board's support for the Petition, and the placement of a plaque on the Memorial Parkway recognizing Thurston William "Bill" Wallace for his service to the Brighton Community.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

<u>Section 1.</u> A plaque shall be placed on the Memorial Parkway recognizing Thurston William "Bill" Wallace for his service to the Brighton Community.
