Nearby Jurisdictions' Compensation

JURISDICTION	PLANNING COMMISSION COMPENSATION	OTHER BOARDS AND COMMISSIONS COMPENSATION
Anada	\$100 per meeting	Liquor Authority Board (\$75 per meeting)
Aurora	\$100 per month	No other boards and commissions receive financial compensation
Adams County	\$60 per meeting	Board of Adjustment
Commerce City ⁽¹⁾	\$50 per meeting	Board of Adjustment
Fort Lupton	Does not receive financial compensation	No other boards and commissions receive financial compensation
Lockbuie ⁽²⁾	N/A	N/A
Northglenn ⁽³⁾	\$20 per regular meeting	Board of Adjustment (\$20 per meeting)
Thornton ⁽⁴⁾	\$50 per meeting, Chair receives \$60 per meeting	All boards are paid
Weld County	Does not receive financial compensation	No other boards and commissions receive financial compensation
Westminster	Does not receive financial compensation	No other boards and commissions receive financial compensation

(1) Advisory members receive \$25 per meeting they attend.
(2) Does not have a Planning Commission as everything is sent to their Board of Trustees who are compensated monthly.
(3) Does not receive financial compensation for study sessions.
(4) Paid as Planning Commissioner with a Permit and Appeals Board, who receives compensation as noted.

Incentives and Recognitions

- Two municipalities, in addition to Brighton, provide a recreational incentive.
- The majority of jurisdictions do not offer additional incentives.
- Almost all jurisdictions provide ways to recognize their commissioners by providing dinner at each public meeting, an annual holiday banquet, an end of year gift, etc.

Recruitment

- Only one jurisdiction expressed they have significant interest in joining boards and commissions.
- Most jurisdictions expressed they receive adequate interest, being able to fill most vacancies, and tend to have a few waiting lists for select boards.
- Two jurisdictions expressed difficulty in recruiting for vacancies.
- Recruitment efforts tend to come from utilizing social media, websites, recruitment events with staff, and relying on the networks of involved parties.
