

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ENTERPRISE, ACCEPTING THE BID OF LANDMARK ENGINEERING, AND AWARDING THE CONTRACT FOR THE VARIOUS WATER DISTRIBUTION LINES DESIGN PROJECT #98703, IN AN AMOUNT NOT TO EXCEED EIGHTY SEVEN THOUSAND FIVE HUNDRED FIFTY DOLLARS (\$87,550.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting bids through its formal solicitation process for completion of the Various Water Distribution Lines Design Project, (ITB #17-018); and

**WHEREAS**, funding was approved in the 2017 Budget; and

**WHEREAS**, Landmark Engineering submitted a bid for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Landmark Engineering is the lowest and most responsive and responsible bidder for the Various Water Distribution Lines Design Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the bid of Landmark Engineering, in the amount of Eighty Seven Thousand Five Hundred Fifty Dollars (\$87,550.00), to award the contract for the Various Water Distribution Lines Design Project to Landmark Engineering, in an amount not to exceed Eighty Seven Thousand Five Hundred Fifty Dollars (\$87,550.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ENTERPRISE, AS FOLLOWS:**

1. That Landmark Engineering is the lowest responsive and responsible bidder for the Various Water Distribution Lines Design Project; and
2. That the bid of Landmark Engineering in the amount of Eighty Seven Thousand Five Hundred Fifty Dollars (\$87,550.00), is hereby approved; and
3. That funding was approved in the 2017 Budget; and
4. That the Contract for the Various Water Distribution Lines Design Project is hereby awarded to Landmark Engineering in the amount of Eighty Seven Thousand Five Hundred Fifty Dollars (\$87,550.00); and
5. That the Mayor is hereby authorized to sign the contract with Landmark Engineering, on behalf of the City, and the City Clerk to Attest thereto.
