WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal solicitation process for completion of the 2017 CIP and Overlay Project, (ITB #17-035 R); and

WHEREAS, funding was approved in the 2017 Budget; and

WHEREAS, Asphalt Specialties Company, submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that Asphalt Specialties Company, is the lowest and most responsive and responsible bidder for the 2017 CIP Patch and Overlay Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the bid of Asphalt Specialties Company, in the amount of One Million Six Hundred Eighty Nine Thousand One Hundred Ninety Four Dollars and Twenty Five Cents (\$1,689,194.25), to award the contract for the 2017 CIP Patch Overlay Project to Asphalt Specialties Company, in an amount not to exceed One Million Six Hundred Eighty Nine Thousand One Hundred Ninety Four Dollars and Twenty Five Cents (\$1,689,194.25), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

- 2. That the bid of Asphalt Specialties Company in the amount of One Million Six Hundred Eighty Nine Thousand One Hundred Ninety Four Dollars and Twenty Five Cents (\$1,689,194.25), is hereby approved; and
- 3. That funding was approved in the 2017 Budget; and

- 4. That the Contract for the 2017 CIP Patch and Overlay Project is hereby awarded to Asphalt Specialties Company in the amount not to exceed One Million Six Hundred Eighty Nine Thousand One Hundred Ninety Four Dollars and Twenty Five Cents (\$1,689,194.25); and
- 5. That the Mayor is hereby authorized to sign the contract with Asphalt Specialties Company, on behalf of the City and the City Clerk to Attest thereto.
