

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF J3 ENGINEERING CONSULTANTS, INC., AND AWARDING THE CONTRACT FOR THE DESIGN SERVICES N 45TH AVE BRIDGE STREET TO LONGS PEAK STREET PROJECT, PROJECT# 99927 IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY THREE THOUSAND NINETY ONE DOLLARS (\$123,091.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting proposals through its formal solicitation process for completion of the Design Services N 45th Ave Bridge Street to Longs Peak Street Project (RFP #17-025); and

**WHEREAS**, funding was approved in the 2017 Budget; and

**WHEREAS**, J3 Engineering Consultants, Inc., submitted a proposal for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that J3 Engineering Consultants, Inc., is the firm having the requisite expertise and experience to perform the required services for the Design Services N 45th Ave Bridge Street to Longs Peak Street Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the proposal of J3 Engineering Consultants, Inc., in the amount of One Hundred Twenty Three Thousand Ninety One Dollars (\$123,091.00), to award the contract for the Design Services N 45th Ave Bridge Street to Longs Peak Street Project to J3 Engineering Consultants, Inc. , in an amount not to exceed One Hundred Twenty Three Thousand Ninety One Dollars (\$123,091.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That J3 Engineering Consultants, Inc. is the firm having the requisite expertise and experience to perform the required services for the Design Services N 45th Ave Bridge Street to Longs Peak Street Project; and
2. That the Proposal of J3 Engineering Consultants, Inc. in the amount of One Hundred Twenty Three Thousand Ninety One Dollars (\$123,091.00), is hereby approved; and
2. That funding was approved in the 2017 Budget; and

3. That the Contract for the Design Services N 45th Ave Bridge Street to Longs Peak Street Project is hereby awarded to J3 Engineering Consultants, Inc. in the amount not to exceed One Hundred Twenty Three Thousand Ninety One Dollars (\$123,091.00); and
4. That the Mayor is hereby authorized to sign the contract with J3 Engineering Consultants, Inc. , on behalf of the City and the City Clerk to Attest thereto.
