A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE BID OF J3 ENGINEERING CONSULTANTS, AND AWARDING THE CONTRACT FOR THE BASELINE ROAD WATER LINE DESIGN PROJECT #98703, IN AN AMOUNT NOT TO EXCEED EIGHTY-NINE THOUSAND SEVEN HUNDRED TWENTY-ONE DOLLARS (\$89,721.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, Sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal solicitation process for completion of the Baseline Road Water Line Design Project, (ITB#17-041); and

WHEREAS, funding was approved in the 2017 budget; and

WHEREAS, J3 Engineering Consultants submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that J3 Engineering Consultants is the most responsive and responsible bidder for the Baseline Road Water Line Design Project; and

WHEREAS, the City believes that it is in the best interest of the City to accept the bid of J3 Engineering Consultants, in the amount of Eighty-Nine Thousand Seven Hundred Twenty-One Dollars (\$89,721.00), to award the contract for the Baseline Road Water Line Design Project to J3 Engineering Consultants, in an amount not to exceed of Eighty-Nine Thousand Seven Hundred Twenty-One Dollars (\$89,721.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, AS FOLLOWS:

1. That J3 Engineering Consultants is the most responsive and responsible bidder for the Baseline Road Water Line Distribution Project; and
2. That the bid of J3 Engineering Consultants in the amount of Eighty-Nine Thousand Seven Hundred Twenty-One Dollars (\$89,721.00), is hereby approved; and

3. That funding was approved in the 2017 Budget; and
4. That the Contract for the Baseline Road Water Line Design Project is hereby awarded to J3 Engineering Consultants in the amount of Eighty-Nine Thousand Seven Hundred Twenty-One Dollars (\$89,721.00); and
5. That the Mayor is hereby authorized to sign the contract with J3 Engineering Consultants, on behalf of the City, and the City Clerk to attest thereto.
