A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF WALKER PARKING CONSULTANTS, AND AWARDING THE CONTRACT FOR THE CITY OF BRIGHTON PARKING MANAGEMENT PLAN PROJECT, IN AN AMOUNT NOT TO EXCEED SEVENTY SEVEN THOUSAND FOUR HUNDRED FIFTY DOLLARS (\$77,450.00), AUTHORIZING A 2017 BUDGET AMENDMENT IN THE AMOUNT OF TWENTY SEVEN THOUSAND FOUR HUNDRED FIFTY DOLLARS (\$27,450) AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting proposals through its formal solicitation process for completion of the City of Brighton Parking Management Plan Project, (RFP #17-027); and

WHEREAS, the anticipated total expense for the Project is \$77,450; and

WHEREAS, funding was approved in the City of Brighton 2017 Adopted Budget of \$50,000 and funding was approved in the Brighton Urban Renewal Authority 2017 Adopted Budget of \$27,450; and

WHEREAS, the City of Brighton City Council believes that is reasonable and proper for the City to authorize a 2017 Budget Amendment appropriating the \$27,450 expense reimbursement from the Brighton Urban Renewal Authority in account 10-21-4650-30005;

WHEREAS, Walker Parking Consultants, submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that Walker Parking Consultants, is the firm having the requisite expertise and experience to perform the required services for the City of Brighton Parking Management Plan Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the proposal of Walker Parking Consultants, in the amount of Seventy Seven Thousand Four Hundred Fifty Dollars (\$77,450.00), to award the contract for the City of Brighton Parking Management Plan Project to Walker Parking Consultants, in an amount not to exceed Seventy Seven Thousand Four Hundred Fifty Dollars (\$77,450.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

- 1. That Walker Parking Consultants is the firm having the requisite expertise and experience to perform the required services for the City of Brighton Parking Management Plan Project; and
- 2. That the Proposal of Walker Parking Consultants in the amount of Seventy Seven Thousand Four Hundred Fifty Dollars (\$77,450.00), is hereby approved; and
- 3. That the City of Brighton 2017 adopted budget is hereby amended and appropriated for the fiscal year beginning January 1, 2017 and ending December 31, 2017, in account number 10-21-4650-30005 as follows:
