WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall* establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting proposals through its formal solicitation process for completion of the Land Use and Development Code Update Project, (RFP #17-037); and

WHEREAS, funding was approved in the 2017 Budget; and

WHEREAS, Gould Evans, submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that Gould Evans, is the firm having the requisite expertise and experience to perform the required services for the Land Use and Development Code Update Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the proposal of Gould Evans, in the amount of Two Hundred Nineteen Thousand Seven Hundred Forty Nine Dollars (\$219,749.00), to award the contract for the Land Use and Development Code Update Project to Gould Evans, in an amount not to exceed Two Hundred Nineteen Thousand Seven Hundred Forty Nine Dollars (\$219,749.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

- 1. That Gould Evans is the firm having the requisite expertise and experience to perform the required services for the Land Use and Development Code Update Project; and
- 2. That the Proposal of Gould Evans in the amount of Two Hundred Nineteen Thousand Seven Hundred Forty Nine Dollars (\$219,749.00), is hereby approved; and
- 2. That funding was approved in the 2017 Budget; and
- 3. That the Contract for the Land Use and Development Code Update Project is hereby awarded to Gould Evans in the amount not to exceed Two Hundred Nineteen Thousand Seven Hundred Forty Nine Dollars (\$219,749.00); and

4. That the Mayor is hereby authorized to sign the contract with Gould Evans, on behalf of the City and the City Clerk to Attest thereto.
