**WHEREAS,** C.R.S. § 29-1-203 authorizes governments to cooperate and contract with one another to provide any function, service, or facility lawfully authorized to each; and

WHEREAS, the cities of Brighton and Commerce City have cooperated in the past and previously entered an intergovernmental agreement establishing a shared victim services unit; and

**WHEREAS,** the cities of Brighton and Commerce City wish to revise the previous agreement through the execution of a new agreement to address the cost sharing, structure, administration, and funding of the shared Victim Services Unit, substantially in the form attached as Exhibit A ("Intergovernmental Agreement for Shared Sexual Assault Task Force"); and

WHEREAS, the City Council hereby finds and determines that the terms of the Intergovernmental Agreement and fair and reasonable and that it is in the best interests of the citizens of Brighton that the City enter into said Agreement with Commerce City.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

- 1. The Intergovernmental Agreement for Shared Victim Service Unit, a copy of which is attached hereto as Exhibit A, is hereby approved.
- 2. The Mayor and the City Clerk are hereby authorized and directed to sign and attest the Intergovernmental Agreement for Shared Victim Service Unit, substantially in the form attached as Exhibit A.
- 3. The City Manager is hereby authorized to execute such documents and undertake such tasks as may be required to implement the terms of Intergovernmental Agreement for Shared Victim Service Unit on behalf of the City.
