WHEREAS, on June 13, 2017 the City Council of the City of Brighton, Colorado, at a Special City Council meeting, adopted Resolution 2017-63 approving participation by the City of Brighton in a Coordinated Election to be conducted by the Adams County Clerk and Recorder and the Weld County Clerk and Recorder on November 7, 2017; and

WHEREAS, the Canvass Judges from Adams and Weld Counties have completed their respective Certified Abstract of Votes Cast, and have submitted such certified election results to the City Clerk. The combined tally from both Counties for the Coordinated Election is as follows:

WHEREAS, pursuant to C.R.S. Section 1-11-103(2), after the final Abstract of Votes Cast has been prepared and certified, the Designated Election Official shall notify the local governing body of the election results; and

WHEREAS, accordingly, the Adams County and Weld County Canvass Boards reviewed the November 7, 2017 Coordinated Election procedures and election results, and certified the Abstract of Votes Cast on November 22, 2017 and November 18, 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, AS FOLLOWS:

- 1. That Brighton Ballot Issue 2J failed.
- 2. That no candidate for the City of Brighton Mayor contest received a majority of the votes cast for such office as required in Article III, Section 3.6 of the City of Brighton Charter, thereby necessitating the special run-off municipal election by the voters of the City of Brighton between the two candidates with the highest number of votes at the general election, to wit, Wayne Scott and Ken Kreutzer.
- 3. That no candidate for the City of Brighton Ward I contest received a majority of the votes cast for such office as required in Article III, Section 3.6 of the City of Brighton Charter, thereby necessitating the special run-off municipal election by the voters of Ward I between the two candidates with the highest number of votes at the general election, to wit, Joan Kniss and Matt Johnston.
- 4. That no candidate for the City of Brighton Ward II contest received a majority of the votes cast for such office as required in Article III, Section 3.6 of the City of Brighton Charter, thereby necessitating the special run-off municipal election by the voters of Ward II between the two candidates with the highest number of votes at the general election, to wit, Gregory Mills and Ferman "Sonny" Maestas.
- 5. That Clint Blackhurst received the highest amount of votes for the City of Brighton Ward III contest and was elected Councilmember from Ward III and shall serve for four (4) years commencing January 2, 2017.
- 6. That Mark Humbert received the highest amount of votes for the City of Brighton Ward IV contest and was elected Councilmember from Ward IV and shall serve for four (4) years commencing January 2, 2017.
