- 2. That **Matt Johnston** received the highest amount of votes for the City of Brighton Ward 1 contest and was elected Councilmember from Ward 1, and shall serve for four years commencing January 2, 2018.
- 3. That **Gregory Mills** received the highest amount of votes for the City of Brighton Ward 2 contest and was elected Councilmember from Ward 2, and shall serve for four years commending January 2, 2018.
