A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE PROPOSAL OF GLACIER CONSTRUCTION COMPANY, INC., AND AWARDING THE CONTRACT FOR THE GREENSAND FILTER EFFLUENT LINE VALVE REPLACEMENT PROJECT TO GLACIER CONSTRUCTION COMPANY, INC. IN AN AMOUNT NOT TO EXCEED FIFTY-NINE THOUSAND, THREE HUNDRED FORTY DOLLARS AND ZERO CENTS (\$59,340.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies"; and

**WHEREAS,** Chapter 3.08 of the Brighton Municipal Code, Sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS,** the City published a notice inviting proposals through its formal solicitation process for completion of the Greensand Filter Effluent Line Valve Replacement Project, (ITB# 18-009); and

WHEREAS, funding was approved in the 2018 budget; and

**WHEREAS,** Glacier Construction Company Inc. submitted a proposal for the project which has been reviewed by the City; and

**WHEREAS,** the City believes that Glacier Construction Company Inc. is the most responsive and responsible respondent for the Greensand Filter Effluent Line Valve Replacement Project; and

WHEREAS, the City believes that it is in the best interest of the City to accept the proposal of Glacier Construction Company Inc., in the amount of Fifty-Nine Thousand and Three Hundred and Forty Dollars and Zero Cents (\$59,340.00), to award the contract for the Greensand Filter Effluent Line Valve Replacement Project to Glacier Construction Company Inc. in an amount not to exceed of Fifty-Nine Thousand and Three Hundred and Forty Dollars and Zero Cents (\$59,340.00), and to authorize the Mayor to sign the contract on behalf of the City, and the City Clerk to Attest thereto.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, AS FOLLOWS:

- 1. That Glacier Construction Company, Inc., is the most responsive and responsible bidder for the Greensand Filter Effluent Line Valve Replacement Project; and
- 2. That the bid of Glacier Construction Company Inc., Inc. in the amount of Fifty-Nine Thousand and Three Hundred and Forty Dollars and Zero Cents (\$59,340.00), is hereby approved; and
- 3. That funding was approved in the 2018 Budget; and
- 4. That the Contract for the Greensand Filter Effluent Line Valve Replacement Project is hereby awarded to Glacier Construction Company Inc. in the not-to-exceed amount of Fifty-Nine Thousand and Three Hundred and Forty Dollars and Zero Cents (\$59,340.00); and
- 5. That the Mayor is hereby authorized to sign the contract with Glacier Construction Company Inc., on behalf of the City, and the City Clerk to Attest thereto.
