

A RESOLUTION OF THE CITY COUNCIL OF CITY OF BRIGHTON, COLORADO APPROVING AN “INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF BRIGHTON AND THE ADAMS COUNTY SHERIFF’S OFFICE FOR THE PROVISION OF LAW ENFORCEMENT AND ADMINISTRATIVE PERSONNEL”; AUTHORIZING THE CITY MANAGER TO EXECUTE SAID IGA ON BEHALF OF THE CITY AND TO UNDERTAKE SUCH TASKS AND EXECUTE SUCH DOCUMENTS AS MAY BE REQUIRED TO IMPLEMENT SAID IGA ON BEHALF OF THE CITY.

WHEREAS, Brighton has requested administrative services be provided by Adams County on a continuous basis between the hours of 2200hrs and 0600hrs, 365 days/year; and

WHEREAS, such administrative services shall include, generally, NCIC and CCIC terminal monitoring; hit confirmations; warrant, person(s), vehicle(s), property and other entries and clearances, as needed; impounds and private tows; and

WHEREAS, Adams County employs a number of personnel who are qualified and able to assist Brighton with the performance of said administrative services; and

WHEREAS, Brighton and Adams County have entered into an Intergovernmental Agreement (IGA) so that Brighton may use the services of Adams County employees (referred to in said IGA as “Assigned Employees”) to render, as applicable, administrative services during the hours of 2200hrs and 0600hrs only specifically designated by Adams County throughout the term of this IGA; and

WHEREAS, the City Council finds and determines that the terms of the IGA are reasonable, that this IGA exemplifies the spirit of cooperation between the City and County, and that it is in the best interests of the citizens of Brighton that the IGA be approved.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

1. That the “*INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF BRIGHTON AND THE ADAMS COUNTY SHERIFF’S OFFICE FOR THE PROVISION OF LAW ENFORCEMENT AND ADMINISTRATIVE PERSONNEL*”, a copy of which is attached hereto, is hereby approved.
2. That the City Manager is authorized to execute said IGA on behalf of the City and to undertake such tasks and execute such documents as may be required to implement said IGA on behalf of the City.
