

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF INTEGRATED SITE SERVICES, INC., AND AWARDING THE CONTRACT FOR THE BJAA PARK CONSTRUCTION PROJECT #17001, IN AN AMOUNT NOT TO EXCEED ONE MILLION ONE HUNDRED TWENTY THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$1,120,215.00) TO INTEGRATED SITE SERVICES, INC. AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**RESOLUTION NO. 2018-56**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting bids through its formal solicitation process for completion of the BJAA Park Construction Project, (ITB #18-011); and

**WHEREAS**, Funding was approved in the 2018 Adopted Budget for BJAA Park Construction in the amount of \$540,350.00. An additional \$679,700.00 was approved by Council as part of the First Quarter 2018 Budget Amendment on April 17, 2018. This brings the overall 2018 project budget to \$1,220,050.00: and

**WHEREAS**, Integrated Site Services, Inc., submitted a bid for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Integrated Site Services, Inc., is the lowest and most responsive and responsible bidder for the BJAA Park Construction Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the bid of Integrated Site Services, Inc., in the amount of One Million One Hundred Twenty Thousand Two Hundred Fifteen Dollars (\$1,120,215.00), to award the contract for the BJAA Park Construction Project to Integrated Site Services, Inc., in an amount not to exceed One Million One Hundred Twenty Thousand Two Hundred Fifteen Dollars (\$1,120,215.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That Integrated Site Services, Inc., is the lowest responsive and responsible bidder for the BJAA Park Construction Project ; and
2. That the bid of Integrated Site Services, Inc., in the amount of One Million One Hundred Twenty Thousand Two Hundred Fifteen Dollars (\$1,120,215.00), is hereby approved; and
3. That Funding was approved in the 2018 Adopted Budget for BJAA Park Construction, in the amount of \$540,350.00. An additional \$679,700.00 was approved by Council as part of the First Quarter 2018 Budget Amendment on April 17, 2018. This brings the overall 2018 project budget to \$1,220,050.00: and

4. That the Contract for the BJAA Park Construction Project is hereby awarded to Integrated Site Services, Inc., in the amount not to exceed One Million One Hundred Twenty Thousand Two Hundred Fifteen Dollars (\$1,120,215.00); and
5. That the Mayor is hereby authorized to sign the contract with Integrated Site Services, Inc., on behalf of the City and the City Clerk to Attest thereto.
