

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE BID OF JALISCO INTERNATIONAL, INC. AND AWARDING THE CONTRACT FOR THE I-76 AND BROMLEY ROUNDABOUT IMPROVEMENTS PROJECT, PROJECT# 90750, IN AN AMOUNT NOT TO EXCEED Nine Hundred Ninety Nine Thousand Six Hundred Thirty Two Dollars and Ninety Six cents (\$999,632.96), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.**

**RESOLUTION NO. 2018-81**

**WHEREAS**, pursuant to Section 17.7 of the City of Brighton Charter, "*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*"; and

**WHEREAS**, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

**WHEREAS**, the City published a notice inviting bids through its formal solicitation process for completion of the I-76 and Bromley Roundabout Improvements Project, (ITB #18-027); and

**WHEREAS**, funding was approved in the 2018 Budget; and

**WHEREAS**, Jalisco International, Inc. submitted a bid for the project which has been reviewed by the City; and

**WHEREAS**, the City believes that Jalisco International, Inc. is the lowest and most responsive and responsible bidder for the I-76 and Bromley Roundabout Improvements Project; and

**WHEREAS**, the City believes that it is in the best interests of the City to accept the bid of Jalisco International, Inc. in the amount of Nine Hundred Ninety Nine Thousand Six Hundred Thirty Two Dollars and Ninety Six cents (\$999,632.96), to award the contract for the I-76 and Bromley Roundabout Improvements Project to Jalisco International, Inc. in an amount not to exceed Nine Hundred Ninety Nine Thousand Six Hundred Thirty Two Dollars and Ninety Six cents (\$999,632.96), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:**

1. That Jalisco International, Inc. is the lowest responsive and responsible bidder for the I-76 and Bromley Roundabout Improvements Project; and
2. That the bid of Jalisco International, Inc. in the amount of Nine Hundred Ninety Nine Thousand Six Hundred Thirty Two Dollars and Ninety Six cents (\$999,632.96), is hereby approved; and
3. That funding was approved in the 2018 Budget; and

4. That the Contract for the I-76 and Bromley Roundabout Improvements Project is hereby awarded to Jalisco International, Inc. in the amount not to exceed Nine Hundred Ninety Nine Thousand Six Hundred Thirty Two Dollars and Ninety Six cents (\$999,632.96); and
5. That the Mayor is hereby authorized to sign the contract with Jalisco International, Inc. on behalf of the City and the City Clerk to Attest thereto.
