WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, "The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies"; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting bids through its formal solicitation process for completion of the Roof Replacement for Two City Buildings Project, (ITB #18-025); and

WHEREAS, Funding was approved in the EPC Projects Phase II budget for the Roof Replacement for Two City Buildings Project; and

WHEREAS, North West Roofing, submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that North West Roofing, is the lowest and most responsive and responsible bidder for the Roof Replacement for Two City Buildings Project; and

WHEREAS, the City believes that it is in the best interests of the City to accept the bid of North West Roofing, in the amount of Ninety Five Thousand Two Hundred Dollars (\$95,200.00), to award the contract for the Roof Replacement for Two City Buildings Project to North West Roofing, in an amount not to exceed Ninety Five Thousand Two Hundred Dollars (\$95,200.00), and to authorize the Mayor to sign the contract on behalf of the City and the City Clerk to Attest thereto.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

- 1. That North West Roofing, is the lowest responsive and responsible bidder for the Roof Replacement for Two City Buildings Project; and
- 2. That the bid of North West Roofing, in the amount of Ninety Five Thousand Two Hundred Dollars (\$95,200.00), is hereby approved; and
- 3. That Funding was approved in the EPC Projects Phase II budget for the Roof Replacement for Two City Buildings Project; and

- 4. That the Contract for the Roof Replacement for Two City Buildings Project is hereby awarded to North West Roofing, in the amount not to exceed Ninety Five Thousand Two Hundred Dollars (\$95,200.00); and
- 5. That the Mayor is hereby authorized to sign the contract with North West Roofing, on behalf of the City and the City Clerk to Attest thereto.
