

RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, ACCEPTING THE BID OF STEELOCK GENERAL FENCE CONTRACTOR AND AWARDING THE CONTRACT FOR THE UTILITIES INFRASTRUCTURE FENCING PROJECT TO STEELOCK GENERAL FENCE CONTRACTOR IN AN AMOUNT NOT TO EXCEED SEVEN HUNDRED NINETY-FOUR THOUSAND, SIX HUNDRED DOLLARS (\$794,600.00) AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO.

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “*The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies*”; and

WHEREAS, Chapter 3.08 of the Brighton Municipal Code, Sets forth the requirements and procedures for purchasing of supplies or services and contracting for public works or professional services; and

WHEREAS, the City published a notice inviting qualifications through its formal solicitation process, resulting in the short-listing of four pre-qualified engineering consultants; and

WHEREAS, the City subsequently published a notice inviting bids through its formal solicitation process for completion of the Utilities Infrastructure Fencing Project, (ITB# 18-029); and

WHEREAS, funding was approved in the 2018 budget; and

WHEREAS, Steelock General Fence Contractor submitted a bid for the project which has been reviewed by the City; and

WHEREAS, the City believes that Steelock General Fence Contractor is the most responsive and responsible bidder for the Utilities Infrastructure Fencing Project; and

WHEREAS, the City believes that it is in the best interest of the City to accept the bid of Steelock General Fence Contractor, in the amount of Seven Hundred Ninety-Four Thousand, Six Hundred Dollars (\$794,600.00), to award the contract for the Utilities Infrastructure Fencing Project to Steelock General Fence Contractor in an amount not to exceed Seven Hundred Ninety-Four Thousand, Six Hundred Dollars (\$794,600.00), and to authorize the Mayor to sign the contract on behalf of the City, and the City Clerk to Attest thereto.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACTING BY AND THROUGH ITS WATER ACTIVITY ENTERPRISE, AS FOLLOWS:

1. That Steelock General Fence Contractor, is the most responsive and responsible bidder for the Utilities Infrastructure Fencing Project; and
2. That the bid of Steelock General Fence Contractor, in the amount of Seven Hundred Ninety-Four Thousand, Six Hundred Dollars (\$794,600.00), is hereby approved; and
3. That funding was approved in the 2018 Budget; and
4. That the Contract for the Utilities Infrastructure Fencing Project is hereby awarded to Steelock General fence Contractor in the amount of Seven Hundred Ninety-Four Thousand, Six Hundred Dollars (\$794,600.00); and
5. That the Mayor is hereby authorized to sign the contract with Steelock General Fence Contractor, on behalf of the City, and the City Clerk to Attest thereto.
