

RESOLUTION NO. 2018-147

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF STANTEC CONSULTING SERVICES, INC. AND AWARDING THE CONTRACT FOR THE WATER, WASTEWATER, AND STORM DRAINAGE UTILITY RATE STUDY TO STANTEC CONSULTING SERVICES INC. IN AN AMOUNT NOT TO EXCEED SEVENTY FIVE THOUSAND DOLLARS (\$75,000.00), AND AUTHORIZING THE MAYOR TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, the City published a notice inviting proposals through its formal solicitation process for the Water, Wastewater, and Storm Drainage Utility Rate Study (RFP# 18-055); and

WHEREAS, funding was approved in the adopted Fiscal Year 2019 Budget for the Water, Wastewater, and Storm Drainage Utility Rate Study; and

WHEREAS, Stantec Consulting Services, Inc., submitted a proposal for the project which has been reviewed by the City; and

WHEREAS, the City believes that Stantec Consulting Services, Inc. is the lowest and most responsive and responsible proposer for the Water, Wastewater, and Storm Drainage Utility Rate Study; and

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies”; and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies or services and contracting for public works or professional services.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

Section 1. That the proposal of Stantec Consulting Services, Inc. in an amount not to exceed Seventy Five Thousand Dollars (\$75,000.00), is hereby accepted;

Section 2. That the Mayor is hereby authorized to sign the contract with Stantec Consulting Services, Inc. on behalf of the City and the City Clerk to Attest thereto.

Section 3. All resolutions or parts of resolutions of the City in direct conflict herewith are hereby rescinded.
