

**HOMESTEAD TO BRIGHTON EAST  
FARMS OIL AND GAS PIPELINES  
CONDITIONAL  
USE PERMIT**

Notice is hereby given that the City Council of the City of Brighton will hold a public hearing regarding an application for a Conditional Use Permit for two parallel, underground pipelines: an 8-inch natural gas pipeline and a 6-inch crude oil pipeline. The pipelines will be located within the southern half of Baseline Road (East 168th Avenue) Right-of-Way and within North 60th Avenue alignment, following the western boundary of Adams County Parcel no. 0156900000193, within Sections 2 and 34, Townships 1 North and 1 South, Range 66 West, 6th Principle Meridian, City of Brighton, Counties of Adams and Weld, State of Colorado.

The City Council will hold said public hearing to consider the application for a Conditional Use Permit at 7:00 p.m. on Tuesday, October 1, 2019. The hearing will take place in the City Council Chambers located on the first floor of City Hall, 500 South 4th Avenue in Brighton, CO. The City Council will hear evidence from City staff, the applicant, and any interested parties and will make a decision on the application thereafter.
