A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, FINDING GOOD CAUSE TO WAIVE THE FORMAL BID PROCESS FOR THE PARK LIGHTING IMPROVEMENTS; FINDING THAT THERE IS SUFFICIENT JUSTIFICATION TO DESIGNATE MUSCO SPORTS LIGHTING, LLC D/B/A MUSCO CORPORATION AS A SINGLE SOURCE SUPPLIER FOR THE PARK LIGHTING IMPROVEMENTS; ACCEPTING THE FAIR AND REASONABLE PROPOSAL OF MUSCO SPORTS LIGHTING, LLC D/B/A MUSCO CORPORATION; AND AWARDING THE CONTRACT FOR THE PARK LIGHTING IMPROVEMENTS TO MUSCO SPORTS LIGHTING, LLC D/B/A MUSCO CORPORATION IN AN AMOUNT NOT TO EXCEED ONE HUNDRED THIRTY FIVE THOUSAND DOLLARS (\$135,000.00), TO MUSCO SPORTS LIGHTING, LLC D/B/A MUSCO CORPORATION; AND AUTHORIZING THE CITY MANAGER TO SIGN THE CONTRACT ON BEHALF OF THE CITY AND THE CITY CLERK TO ATTEST THERETO

WHEREAS, the City of Brighton, Colorado (“City”), solicited a Proposal from a Single Source necessitated because of the uniqueness of the technology required, the services provided and conformity with existing sports field and skate park lighting for the Park Lighting Improvements, Project #19-031 (“Project”); and

WHEREAS, funding was approved in the 2019 budget for the Project; and

WHEREAS, Musco Sports Lighting, LLC d/b/a Musco Corporation submitted a proposal for the Project which has been reviewed by the City; and

WHEREAS, the City believes that Musco Sports Lighting, LLC d/b/a Musco Corporation is the most responsive and responsible proposal for the Project; and

WHEREAS, pursuant to Section 17.7 of the City of Brighton Charter, “The Council shall establish by ordinance procedures requiring competitive bidding for contracts for the procurement of services, equipment, and supplies. Any such ordinance may provide exclusions from the competitive bidding requirements for contracts below an amount specified in the ordinance, for the types of contracts specified in the ordinance, and for the types of services, equipment, or supplies specified in the ordinance;” and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies or services and contracting allowing for Single Source purchases for public works or professional services.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

Section 1. The proposal of Musco Sports Lighting, LLC d/b/a Musco Corporation, in an amount of One Hundred Thirty Five Thousand Dollars (\$135,000.00), is hereby accepted.

Section 2. The City Manager is hereby authorized to sign the contract on behalf of the City, and the City Clerk to attest thereto.

Section 3. All resolutions or parts of resolutions of the City in direct conflict herewith are hereby rescinded.
