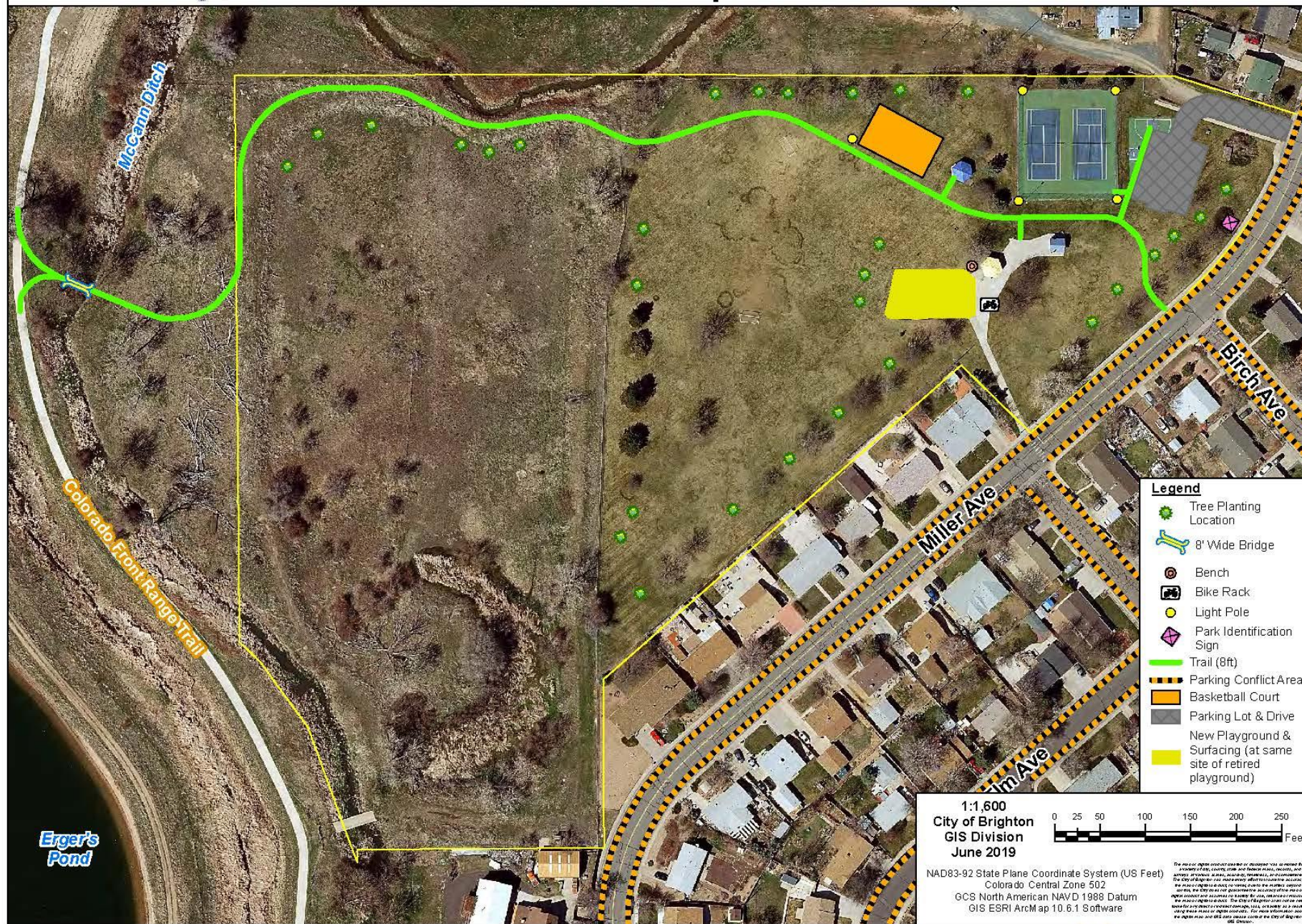

- ❖ Concrete curbing around the playground perimeter
- ❖ Sports court lighting (separate bid)
- ❖ All excavation, erosion control, and revegetation
- ❖ New playground equipment (separate bid, coming to Council in November)



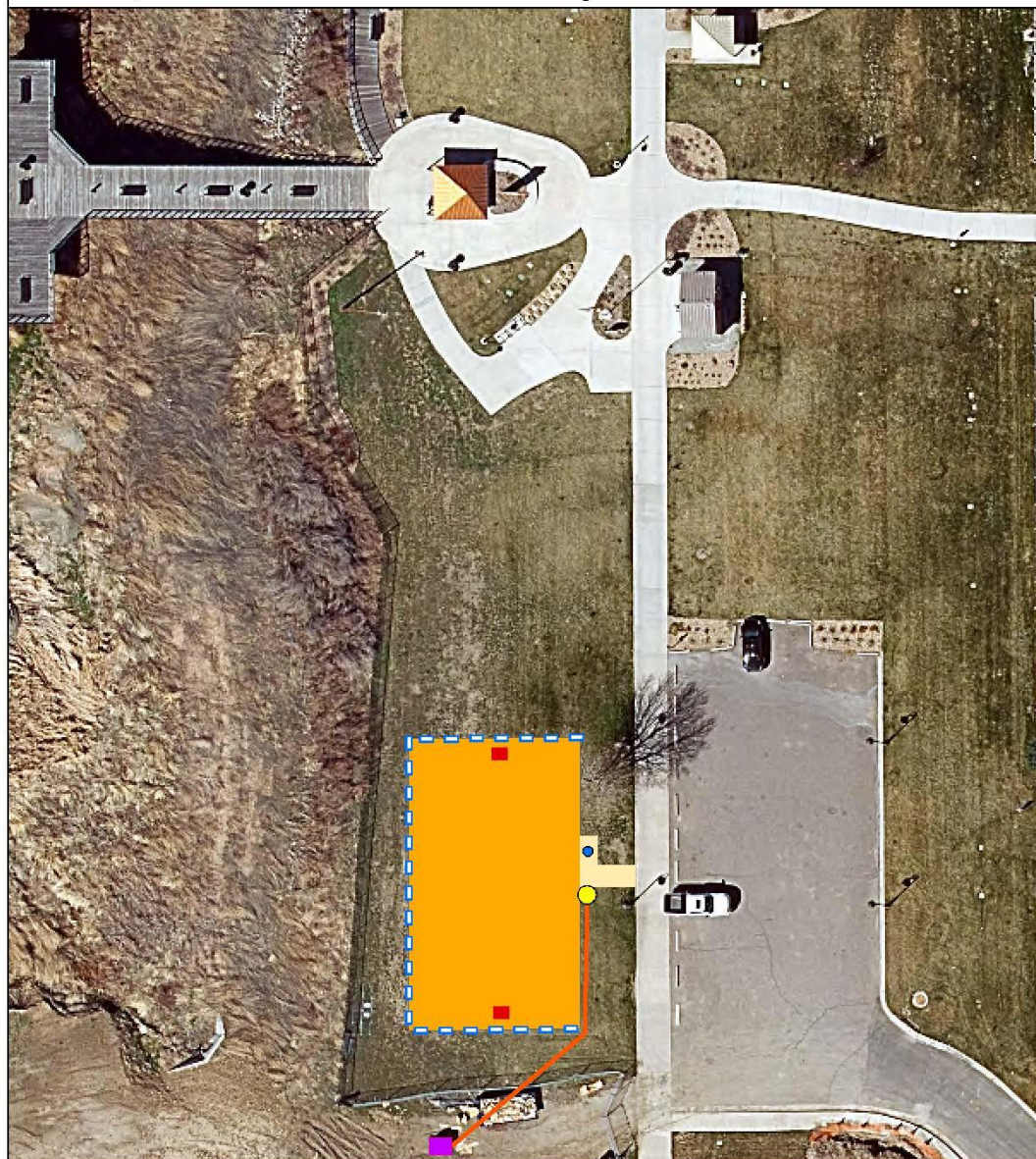


Ken Mitchell Park Basketball Court






Sports Court Lighting

- ❖ Musco sports court lighting is a single source project
- ❖ 5 individual light poles and fixtures at Colorado Park
- ❖ 1 individual light pole and fixtures at Ken Mitchell Park
- ❖ LED System
- ❖ 25 year materials and onsite labor warranty, eliminating 100% of maintenance costs for 25 years
- ❖ Control-Link system for remote on/off control and performance monitoring with 24/7 customer support.
- ❖ **Colorado Park \$105,000**
- ❖ **Ken Mitchell Park \$30,000**
- ❖ **Total bid \$135,000**




Approval of waiver of Bid and award bid for Sport Court Lighting to MUSCO Sports Lighting LLC.

- The City of Brighton has been utilizing Musco lighting since 1998
 - Musco lighting is installed at all of our sports field and court locations that are currently lighted
 - All of existing sports lighting systems have the Control-Link System
 - The Musco lights have a 25 year materials and labor warranty eliminating 100% of maintenance costs for 25 years
 - Musco offers their trademarked Control-Link system that allows remote on/off control and performance monitoring with 24/7 customer support

Staff Recommendation

- ❖ Staff recommends awarding the contract to Arrow J Landscape & Design Inc., the most responsive and responsible bidder in the amount of Six Hundred Sixty Four Thousand Seven Hundred Fifty Two Dollars and Fifty Cents (\$664,752.50)
- ❖ Staff recommends awarding the contract to Musco Sports Lighting, LLC d/b/a Musco Corporation, the single source bidder in the amount of One Hundred Thirty Five Thousand Dollars (\$135,000.00)
