Regulations

- Some cities allow in all zones, but others are specific to the zone type
- 2-4 goat limit (varying by entity)
- Some limit by breed type and some by weight; most do not allow intact males
- Structure and land use regulations have significant variation
- Waste and care is addressed by all
- 5 require a permit, 2 do not
- Slaughter is permitted by half with specific regulations

Municipal Code/Animal Welfare/Considerations

- Section 6-4-10 Definitions Livestock
- Section 6-4-900 Urban agriculture and small animal husbandry
- If approved how will goats be counted against Section 6-4-440 Accumulation of animals
- If approved will residents be required to have a license after having residential inspections and provide proof of vaccinations?
- Disposal of remnants and manure Only 1 disposal provider in the city limits allows for remnants and manure disposal for residential customers
- Sheep and Goat Diseases which can be transmitted to Humans Zoonotic Diseases
- Adams County Animal Shelter has limited capacity, at-large goats will be placed in dog kennels
- City of Fort Collins Section 4-121 <u>Keeping of Goats</u>
