RESOLUTION NO. <u>2020-15</u>

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPROVING THE PLACEMENT OF A PLAQUE ON MEMORIAL PARKWAY RECOGNIZING DICK AND MARY HODGE FOR THEIR SERVICE TO THE BRIGHTON COMMUNITY

WHEREAS, heretofore, the City Council of the City of Brighton adopted Resolution No. 03-14, establishing a Policy for the naming of public amenities and park and recreation facilities in the City of Brighton, including the procedure for selecting Names for recognition on the Memorial Parkway (the "Naming Policy"); and

WHEREAS, the City Clerk has received one Petition, submitted pursuant to and in accordance with the Naming Policy, requesting recognition of Dick and Mary Hodge for their service to the Brighton Community; and

WHEREAS, Dick and Mary Hodge exemplified the true spirt of volunteerism and public service in Brighton. Dick Hodge is a local businessman, Boy Scout leader, and community leader. He served 8 years on the Brighton City Council, 2 year as Mayor Pro-Tem, Downtown Development Authority, Historic Preservation Commission, and key community member to bring the Boys and Girls Club to Brighton: and

WHEREAS, Mary Hodge has served 16 year in the State legislature and 3 years as an Adams County Commissioner. She has represented agriculture, local government, and Early Childhood Development concerns throughout her tenure in the legislature; and

WHEREAS, the Parks and Recreation Advisory Board has reviewed the Petition, and has found and determined that the Petition properly meets all of the relevant criteria established by the Naming Policy; and

WHEREAS, The Park and Recreation Advisory Board at their meeting of December 6, 2019 recommended that Dick and Mary Hodge be recognized for their service to the Brighton Community by placing a plaque on the Memorial Parkway; and

WHEREAS, The City Council finds and determines that The Parks and Recreation Advisory Board, at their meeting of December 6, 2019, did unanimously approve the motion recommending to the City Council, the Advisory's Board's support for the Petition, and the placement of a plaque on the Memorial Parkway recognizing Dick and Mary Hodge for their service to the Brighton Community.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

<u>Section 1.</u> A plaque shall be placed on the Memorial Parkway recognizing Dick and Mary Hodge for their service to the Brighton Community.
