RESOLUTION NO. 2020-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO CERTIFYING THE BALLOT CONTENT FOR THE SPECIAL MAIL BALLOT MUNICIPAL ELECTION FOR WARD 2 COUNCIL MEMBER TO BE HELD ON APRIL 28, 2020; DESIGNATING THE VOTING LOCATION AND STAND-ALONE DROP-OFF LOCATIONS; AND SETTING FORTH OTHER DETAILS RELATED THERETO

WHEREAS, on January 21, 2020, the Brighton City Council approved Resolution 2020-11 calling for a Special Mail Ballot Municipal Election for Ward 2 Council Member; and

WHEREAS, nomination petitions for the office of Ward 2 Council Member were received and the signatures thereon verified by the City Clerk and the candidate positions on the ballot have been established by lot.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO AS FOLLOWS:

- 1. That a special mail ballot municipal election by the voters of Ward to select the Council Member for Ward 2 shall be held on April 28, 2020; and
- 2. Every person who has attained the age of eighteen years, is a citizen of the United States, resides in the City of Brighton, Ward 2, Colorado on April 28, 2020, as applicable, and has registered to vote on or before April 28, 2020, shall be eligible to vote in this special mail ballot run-off municipal election.
- 3. The City Clerk is hereby appointed as the designated election official for the April 28, 2020 special mail ballot municipal election for Ward 2.
- 4. The City Clerk is authorized to certify the ballot content and shall notify the County Clerk of Adams County and Weld County of this special mail ballot municipal election and that the list of registered voters shall be supplemented on March 27, 2020, by the County Clerk, including all persons registering to vote on or before March 27, 2020.
- 5. The City Clerk shall publish a notice of the special mail ballot run-off municipal election on April 15, 2020 and April 22, 2020.
- 6. The City Clerk shall mail the ballots to all active registered electors in the City of Brighton, Ward 2 no later than April 13, 2020.
 - 7. The City Clerk shall appoint election judges no later than April 12, 2020.
- 8. The designated voting locations for the special mail ballot run-off municipal election are Brighton City Hall, 500 South 4th Avenue, Brighton, Colorado 80601 and the Brighton Recreation Center, 555 North 11th Avenue, Brighton, Colorado 80601.

9. That the names of the candidates for Councilmember shall appear on the April 28, 2020 ballot as follows and in the following order:
